## ENTITLEMENT INFORMATION

**FREE SCHOOL MEALS & ASSISTANCE WITH SCHOOL CLOTHING can be claimed if you are receiving any one of the following:**

- Income Support
- Income-based Job Seekers Allowance
- Any income related element of Employment and Support Allowance
- Child Tax Credit, but **NOT** in receipt of Working Tax Credit, **and** an income below £16,190 (as assessed by the Inland Revenue)
- Child Tax Credit **and** Working Tax Credit, and an income below £6,420 (as assessed by the Inland Revenue))
- If you are 16 – 18 yrs old and receive any of these benefits in your own right then you can claim for yourself
- If you are an asylum seeker receiving support under part VI of the Immigration & Asylum Act 1999.

### **EVIDENCE REQUIRED**

The Benefits Agency state that an applicant in receipt of any of these benefits is provided with one of the undernoted documents, which must be evidenced with your application:

- A. Current Letter of Entitlement
- B. Tax Credits Award Notice
- C. Home Office Immigration Form

**Under no circumstances will Highland Council make contact with the Benefits Agency to establish benefit entitlement. Claims will not be backdated and will only come into force once the required benefit evidence has been confirmed.**

### **AMOUNT OF ASSISTANCE FOR SCHOOL CLOTHING**

For eligible applications received up until 31 December 2010: -                   **£50 per pupil**

For eligible applications received after 1 January 2011: -                   **£25 per pupil**

Only one payment per pupil per school year is paid

### **Please Note:**

*A new Application needs to be submitted for the start of every new school session in August.*

Successful applications meeting the criteria for eligibility will be entitled to receive Free School Meals and Assistance with School Clothing for each school pupil. Application forms for academic year 2011-12 will be available from June 2011.

- ✚ Free School Meals will be effective immediately and the applicant will be advised in writing.
- ✚ A cheque for Assistance with School Clothing will follow (*normally within 3 weeks of application*). Payment is made directly to the applicant for the sum of £50 for every eligible child in Primary or Secondary school to the address as stated in your application (**if change of address is imminent please indicate your new address**). From January 11 the amount reduces to £25 for every eligible child in Primary or Secondary school. This assistance is not available for Nursery pupils.
- ✚ Payment for assistance with school clothing will be issued from July 10 onwards.
- ✚ Please note: payments will be in the form of an uncrossed cheque.  
**NB Some banks will require photographic proof of identity.**

**Should your circumstances change that affect your entitlement, you must inform the Council's Catering Services immediately.**
