SUMMARY

To inform Members, in terms of Circular 16/1973, with regard to recorded complaints against the Police.

In the period between 1st March 2007 to 30th April 2007, **27** complaints were received with **32** allegations being made. The breakdown of the **32** allegations for the period is:
