Background

The attached table summarises expenditure and income relating to the Highland and Islands Fire Board capital programme recorded in the ledger as at 31st October 2009.

Current Position

Expenditure to the end of October 2009 is £1,043,000, approximately 37% of the annual budget.

Predicted Out-turn

The predicted capital expenditure out-turn of £2,717,000 is £98,000 lower than budgeted expenditure. This predicted under-spend is primarily due to savings in the build costs at Helmsdale £60,000 and Rousay £44,000.

Members should note that the predicted out-turn for site/building acquisitions of £310,000 compared to budget of £300,000 includes: £140,000 in respect of Baltasound, £100,000 in respect of fire training facilities at the Fire Training School in Invergordon and £70,000 for acquisition of a building at Sandwick.

At the September Board Meeting members approved the bringing forward of £300,000 from the 2010/11 vehicle and equipment budget into 2009/10 to protect funding in 2010/11 for the Lochaline partnership build. This is reflected in the estimated outturn figures for vehicles.
