The individual consultation authorities' responses to the SEA screening, the screening report itself and the determination notice can be viewed online.

#### Statement of Reasons

This section sets out why the Council has determined that the Nairn Community Town Centre Plan (Non-Statutory Planning Guidance) will not be subject to a SEA. The reasons are collated from information gathered during the screening process for the SEA, including screening responses from the consultation authorities.

#### Determination

It has been determined by the Highland Council, following advice from the Strategic Environmental Assessment Consultation Authorities (CAs) (SEPA, SNH and Historic Scotland) that a SEA is not required for Fort William Town Centre Action Plan (Non-Statutory Planning Guidance). The individual consultation authorities' responses to the SEA screening, the screening report itself and the determination notice can be viewed online online.

#### Statement of Reasons

This section sets out why the Council has determined that the Fort William Town Centre Action Plan (Non-Statutory Planning Guidance) will not be subject to a SEA. The reasons are collated from information gathered during the screening process for the SEA, including screening responses from the consultation authorities.

The reasons for not carrying out a full SEA can be summarised as follows:

- Two CAs (SEPA and Historic Scotland) consider that the proposed Action Plan is unlikely to have a significant environmental effect. Only SNH advises that the plan could have a significant environmental impact arising from the proposed new west pier and marina, which is one of 14 proposals put forward in the plan for town centre regeneration. SNH's screening response notes the potential to consider this impact, along with cumulative and/or in combination effects, within the current review of the West Highlands and Islands Local Development Plan.
- The proposal to develop a new west pier and marina will be considered as part of the forthcoming SEA screening process for the West Highlands and Islands Local Development Plan, which is expected to be completed in early 2016.

All comments made by the consultation authorities have been taken into consideration in the production of the final document.

The Council will adopt the Fort William Town Centre Action Plan as Non-Statutory Planning Guidance, as recommended/approved by the Lochaber Area Committee on 25 August 2015.
