Minutes of Meeting held 22 June 2017

- 3. Minutes of Previous Meetings:

Notes of the previous Community Justice Partnership Meeting in February and the Community Justice Officers Group Meeting in April were circulated for noting. Both were agreed as correct.

4. Community Justice Update & Terms of Reference:

The Chair invited the meeting to review the Terms of Reference for the Community Justice Partnership.

Roddy queried whether this version was up to date and Margaret confirmed this document related to the new structure of the Partnership. The Terms of Reference were formally adopted by the meeting.

Mhairi queried whether the Alcohol & Drug Partnership had been invited to the meeting as per the Terms of Reference

<u>Action</u> – James Dunbar, Chair of the ADP to be contacted in relation to a member of the ADP being invited on to the Community Justice Partnership – Margaret

Mhairi also informed the meeting that Libby Bligh from Libertie Project may not be able to continue in her role as Third Sector representative due to other commitments.

Margaret spoke to the Community Justice Update paper, which had been circulated containing some background and information in relation to the

Community Justice Plan. No formal feedback from Community Justice Scotland had been received in terms of the plan but CJS have intimated this is expected over the next 9 months. It was outlined that the plan was for a period of 1 year and will feed into the LOIP It sets out targets that are achievable whilst outlining aspirations for the future.

It was acknowledged that the structure of the Partnership has changed.

Taking the plan forward will entail setting baselines in order that performance over the coming years can be measured. The progress of the plan will be monitored throughout the year and certainly within the Community Justice Partnership Meetings. Over the coming months work will be carried out with those who have committed offences and those who have been affected by crime in order that this information can be taken forward into the 3-year plan.

It is anticipated that a Plan Development Day will be held in November 2017.

<u>Action</u> – Set a date for the Plan Development Day - Margaret

Information around the launch of Community Justice Scotland was given and they have intimated that they would like to attend a Partnership Meeting over the coming year. They have also requested that we focus on at least 3 priorities setting baselines in order that progress can be measured. Margaret updated that the Highland Plan covers this.

A Community Justice Coordinators Event was held in Edinburgh on 5 June, however Margaret updated she was unable to attend. Information from that event has been covered in the general update already provided.

5. <u>COPFS Engagement:</u>

Margaret spoke in relation to the meeting which COPFS had held inviting all the Community justice coordinators for the north area. COPFS position is that they will be taking a strategic approach and will look to find areas of common interest, which can possibly be progressed in the north. The meetings will be held quarterly and they cannot guarantee attendance at the local CJP Meetings. A single point of contact will be provided for each local area. The consensus of the Community Justice Partnership meeting was that this approach was not suitable. Linda pointed out that there is a statutory duty to attend the CJP and there shouldn't be any exception otherwise, a 'snowball' effect might ensue. The Chair proposed that a letter be sent to Andrew Shanks at COPFS expressing disappointment.

6. Launch Event/CPP Events/Engagement:

Margaret spoke to the paper, which had been circulated to the meeting in relation to the Launch of the Community Justice Plan Event, which had taken place in May and had been well attended. The community justice film had been shown and there was good discussion generated around how the third sector can engage with community justice.

A press release had been circulated and this resulted in Bill Alexander, Director of Care & Learning with The Highland Council being interviewed by BBC Radio Scotland.

Margaret provided an update around the CPP Events, which had taken place across Highland and intended to hear the views of the community and third sector around the themes of transport; mental health & wellbeing; poverty; engagement & empowerment and safer, resilient communities. Community justice is seen as part of the safer, resilient communities theme, however it seemed to cut across most of the other themes. When asked what support people need to prevent re-offending, the common themes that emerged were –

Preparation for people coming out of prison & multi agency work to support them,

Volunteering opportunities,

Rehabilitative volunteering and community work,

Mentoring,

Early intervention,

Restorative justice,

Person centred approach with individual needs met,

Less custodial sentences where possible and appropriate,

Peer support & networks,

Employability and recruitment of those with an offending history,

Education & literacy issues,

Tackling alcohol & drug dependency,

Availability of services e.g. addiction/mental health,

Diversionary activities for all ages.

The themes will be considered when compiling the 3-year plan.

Joanna MacDonald NHSH and Gary Aitken COPFS joined the meeting.

The Chair provided an overview of the discussions so far and Gary updated the meeting that he would endeavour to manage along to the Community Justice Partnership Meetings where possible and where he couldn't manage then he would send an update.

The Chair updated this was a better response from COPFS than what had gone previously. In relation to the Action previously this would not be needed or a letter to the effect that the partnership had been in touch with the local PF and that he is happy to engage.

<u>Action</u> – Letter to be sent to Andrew Shanks stating that we will not necessarily be able to attend the COPFS meeting and the local PF is willing to engage with the Community Justice Partnership – Margaret on behalf of The Chair

The update on the Paper in Agenda item 6 was resumed.

Margaret updated the meeting that an engagement workshop has been set up for 6 July within HMP Inverness. A meeting with NHS Health Improvement Team who are working within HMP Inverness has also been beneficial as there will be cross-cutting issues with community justice. Liaison will continue through the Health Improvement Strategy Meeting.

Engagement with the Employer & Partnership Manager of DWP has also been beneficial. There are a number of good news stories in relation to their work within the prison, which may be useful to tap into.

Fraser queried whether there was a link between community justice and the Community Partnerships. Margaret updated that there are plans to set up a meeting with the Community Partnership Chairs. The Chair suggested an invitation to the Community Justice Plan Development Day be extended to the Community Partnership Chairs.

<u>Action</u> – Consider extending invitation to Plan Development Day to Community Partnership Chairs - Margaret

PB Report (Small Change for Justice):

Margaret updated the group in relation to the paper that had been circulated around the Small Change for Justice Project. £25,000 could be spent through funding six small projects. A meeting is due to be held on 28 June 2017 to plan further details of the process and Bidding Event. Discussion took place around advertising the project through twitter etc.

8. <u>Centre for Youth & Criminal Justice:</u>

Margaret updated the meeting about the letter that had been received from the Centre for Youth & Criminal Justice offering assistance.

<u>Action</u> – Invitation to be extended to Centre for Youth & Criminal Justice to attend the next Partnership Meeting - Margaret

9. <u>Good News Stories:</u>

The Chair invited James to inform the meeting in relation to a good news story. James provided an overview of the Persistent Offender Project. Funding from SG was used for the project, which targets those persistent offenders who have alcohol or drug dependency. Engagement with the project is voluntary with staff from SW, Prisons Service, Police & Health engaging and motivating clients into services. The evaluation has shown that there is a cost saving to communities and public agencies. Initial feedback has been very positive and where engagement is evident there is a reduction in reoffending. The project has reflected good partnership working which hopefully can be brought to other aspects of the system and to community justice. Linda highlighted that the project has also had a positive effect on those people who are associates of those clients working with the project. Discussion took place that this could be highlighted to the media.

<u>Action</u> – Media/press release in relation to the Persistent Offender Project – James

10.<u>AOCB</u>:

Margaret raised the possibility of considering mapping of meetings for agencies that are linked to community justice. It was highlighted that there are still meetings coming to light, which the Partnership Manager has not been aware of and which might be useful for community justice to tap into.

<u>Action</u> – All partners to identify which partnerships and meetings are attended by their agency, which have a bearing on community justice and report back to Margaret
