ORDER TO EXEMPT LAND FROM ACCESS RIGHTS

THE HIGHLAND COUNCIL (HIGHLAND CAR CLUB LTD SNOWMAN RALLY) ORDER 2015


The Highland Council in exercise of the powers conferred on them by Section 11 (1) of the Land Reform (Scotland) Act 2003 ("the Act") hereby make the following Order:-

1. This Order may be cited as "The Highland Council (Highland Car Club Ltd Snowman Rally) Order 2015", and shall come into operation as follows:  
On Saturday 21st February 2015  
From 07.30 to 13.00 at Meall Mor, Inverness (Plan 1)  
From 08.15 to 14.00 at Millbuie Forest (Killen & Culbo areas) (Plan 2);  
From 10.15 to 16.00 at Strathrory (Plan 3);  
From 10.45 to 16.15 at Morangie Forest (Tain Hill, Aldie & Scotsburn areas) (Plan 4);  
From 12.30 to 18.00 at Achterneed & Rogie (Inchvannie & Contin area) (Plan 5);  
Unless revoked earlier.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The effect of the Order is to exempt land, namely land at Meall Mor, Inverness, Millbuie Forest (Killen & Culbo areas), Strathrory, Morangie Forest (Tain Hill, Aldie & Scotsburn areas) and Achterneed & Rogie (Inchvannie & Contin area), shown delineated in red on the plans numbered 1-5 annexed and signed as relative to this Order, from the access rights which would otherwise be exercisable in respect of that land by virtue of Part 1 of the Act. Rights of way are not affected by this Order.

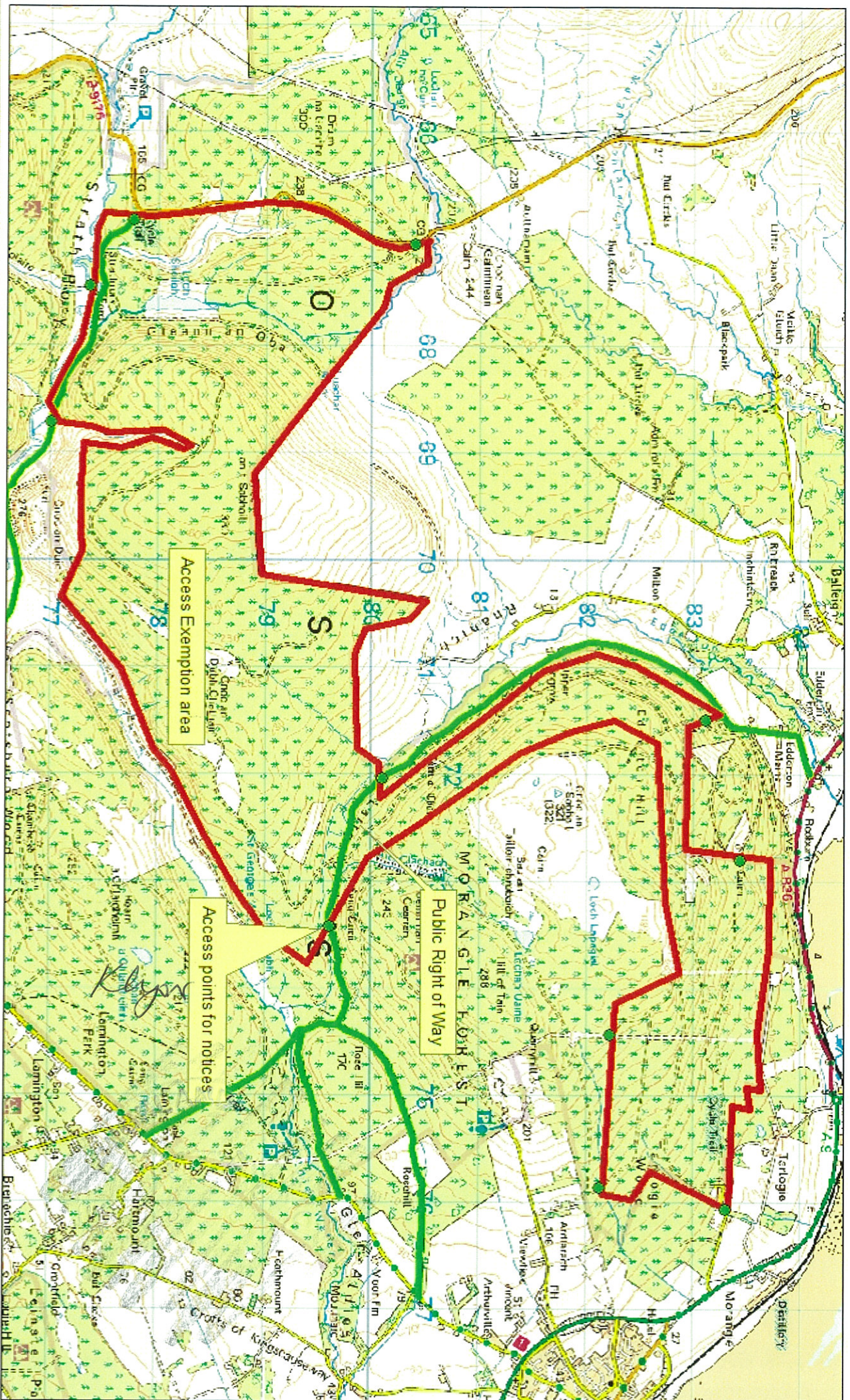

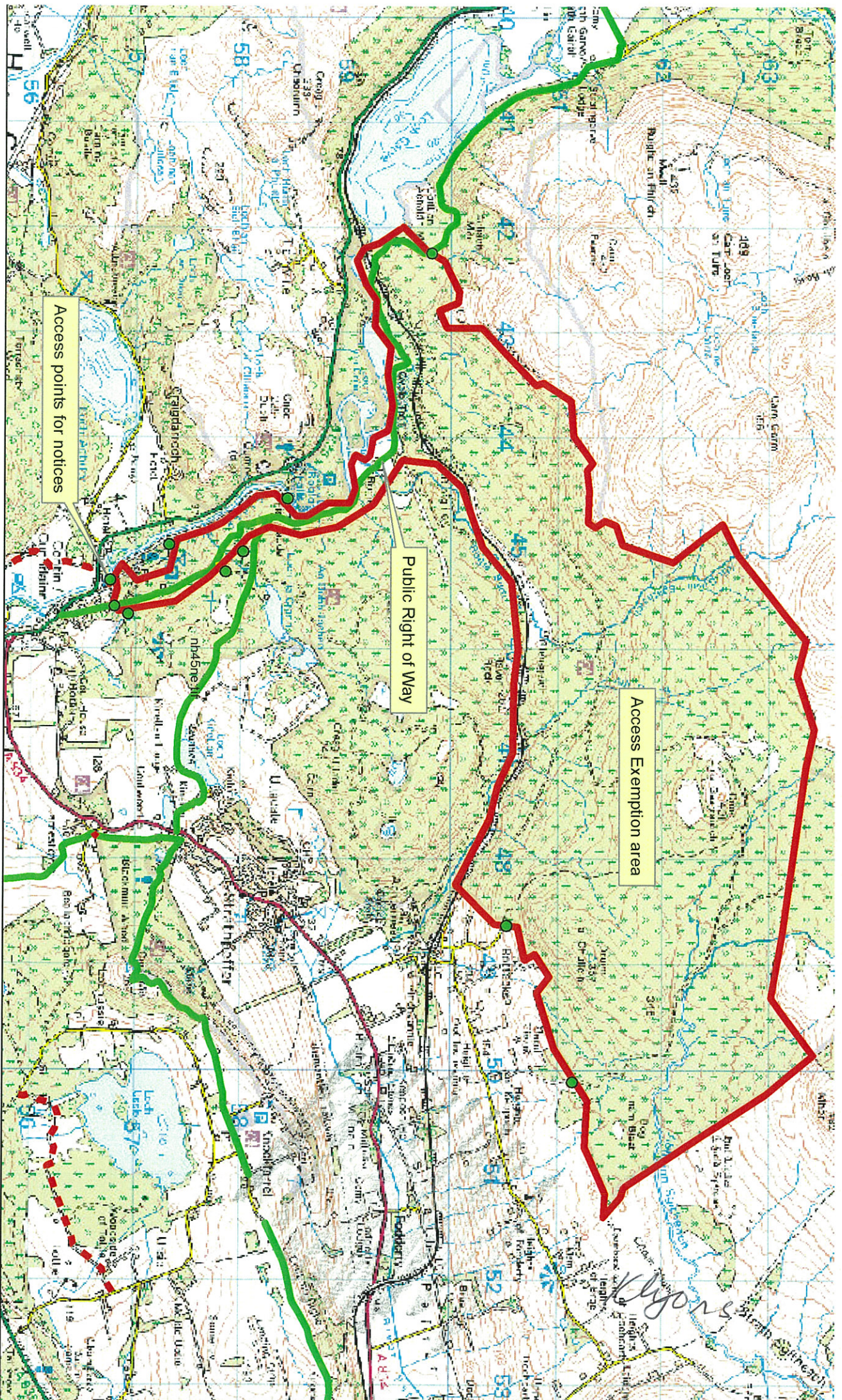
