NOTICE OF ORDER TO EXEMPT LAND FROM ACCESS RIGHTS
THE HIGHLAND COUNCIL (STRAVAIGERS LODGE GRAVEL SPRINT)
ORDER 2015

Notice is hereby given under section 11(9) of the Land Reform (Scotland) Act 2003 ("the Act") that on 17th April 2015, The Highland Council made The Highland Council (Stravaigers Lodge Gravel Sprint) Order 2015 ("the Order") under section 11(1) of the Act for the following dates and events:-

The effect of the Order is to exempt an area of land at Inchnacardoch Forest, Fort Augustus from the access rights which would otherwise be exercisable in respect of that land by virtue of Part 1 of the Act. A Map of the exempted areas can be viewed at the Fort Augustus Service Point, Memorial Hall, Fort Augustus from 0930hrs to 1300hrs Mondays to Fridays and the Development and Infrastructure Service, Council Buildings, Glenurquhart Road, Inverness from 0900hrs to 1700hrs, Mondays to Fridays.

The Order will take effect from 0700hrs on Saturday 9th May 2015 and will expire at 1900hrs on Saturday 9th May 2015 unless revoked earlier.

The purposes for which the Order is made are in the interests of safety and security to allow the staging of the 2015 Stravaigers Lodge Gravel Sprint.

ORDER 2015

The Highland Council in exercise of the powers conferred on them by Section 11 (1) of the Land Reform (Scotland) Act 2003 ("the Act") hereby make the following Order:-

1. This Order may be cited as "The Highland Council (Stravaigers Lodge Gravel Sprint) Order 2015", and shall come into operation at 0700hrs on Saturday 9th May 2015 and shall expire at 1900hrs on Saturday 9th May 2015.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The effect of the Order is to exempt the land at Inchnacardoch Forest, Fort Augustus shown outlined and shaded in red on the plan annexed and signed as relative to this Order from the access rights which would otherwise be exercisable in respect of that land by virtue of Part 1 of the Act

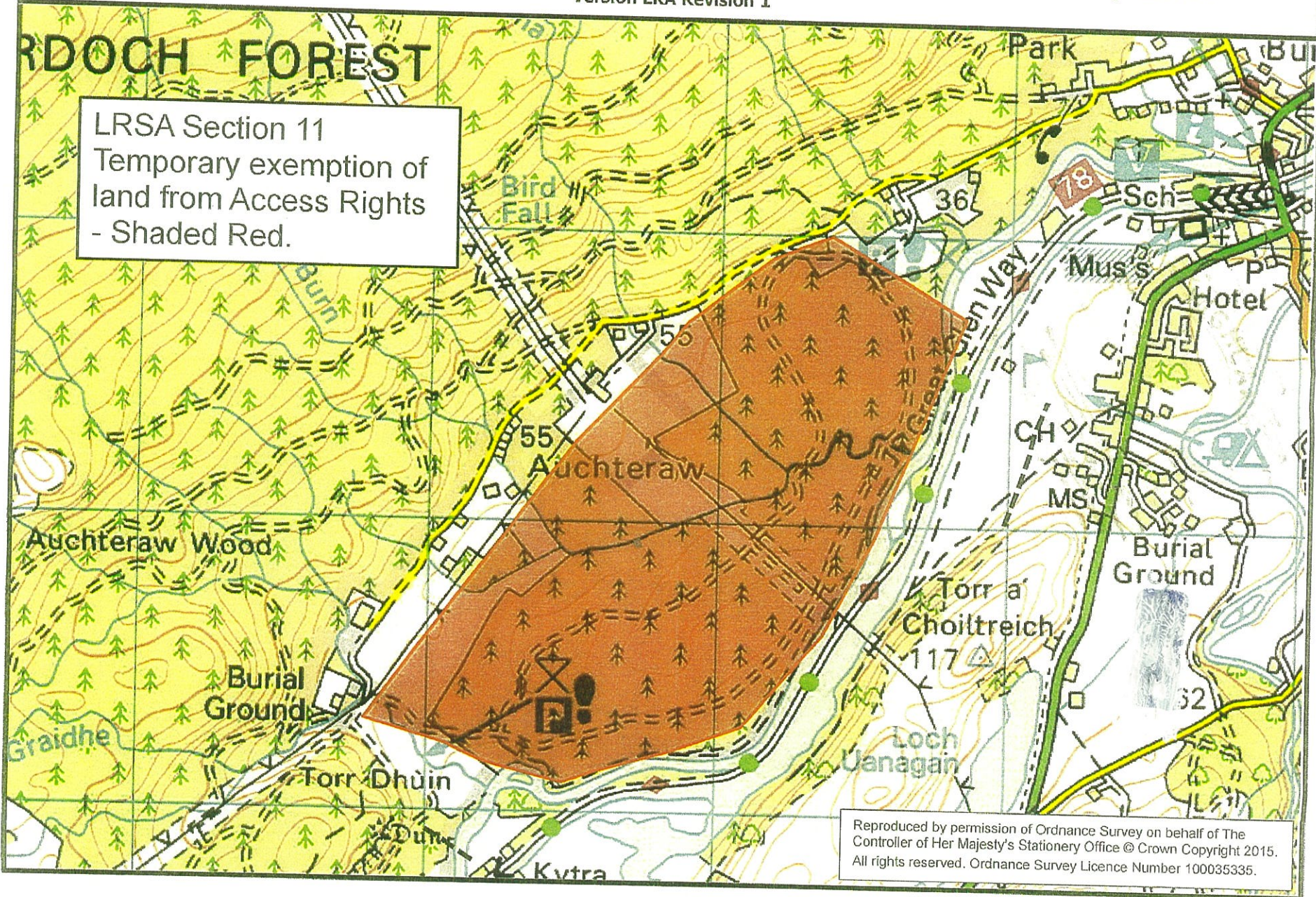
