The effect of the Order will be to exempt a 2.4km² area of land (headland and forested area) at Ardnamurchan Estate, Ardnamurchan from the access rights which would otherwise be exercisable in respect of that land by virtue of Part I of the Act.

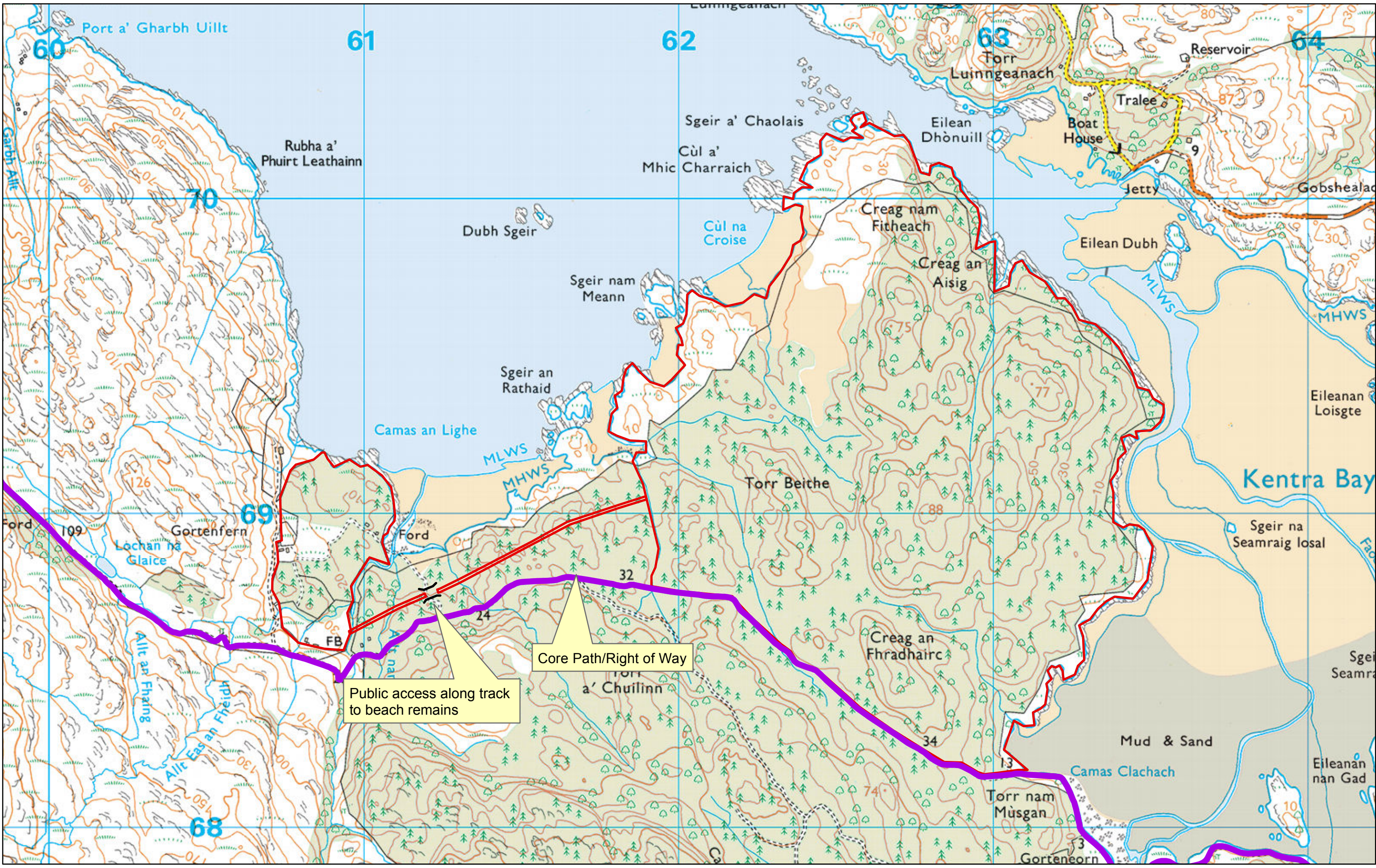

The Land Reform (Scotland) Act 2003 (Highland Council) (Gorteneorn-Ardsnamurchan Estate) Order 20__

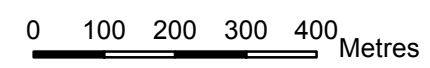
The Highland Council, in exercise of the powers conferred on them by section 11(1) of the Land Reform (Scotland) Act 2003 ("the Act") and of all other powers enabling them in that behalf, having consulted the owner of the land to which the order relates, and the local access forum, and any other person they consider appropriate, having given public notice of the intended purpose and effect of the order, and having considered any objections and representations made to them, all in accordance with section 11(2) of the Act, hereby make the following order:-

1. This order may be cited as The Land Reform (Scotland) Act 2003 (Highland Council) (Gorteneorn-Ardsnamurchan Estate) Order 20__ and shall come into operation during the period beginning at 0001hrs on 7 March 2016 and ending at 2400hrs on 20 March 2017.
2. The effect of this order is to exempt the land extending to 2.4km² (headland and forested area) at Ardsnamurchan Estate, Ardsnamurchan shown delineated in red on the plan annexed and executed as relative hereto from the access rights which would otherwise be exercisable in respect of that land by virtue of Part 1 of the Act.
3. The purpose for which the order is made is to film a TV series and all purposes related thereto including safety and security of participants, personnel and equipment.
