

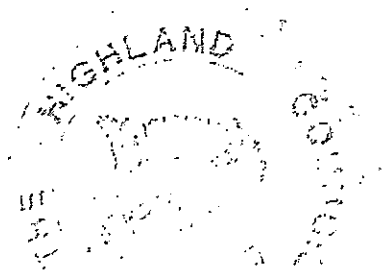

The Land Reform (Scotland) Act 2003 (Highland Council) (Gorteneorn-Ardrnamurchan Estate) Order 2016

The Highland Council, in exercise of the powers conferred on them by section 11(1) of the Land Reform (Scotland) Act 2003 ("the Act") and of all other powers enabling them in that behalf, having consulted the owner of the land to which the order relates, and the local access forum, and any other person they consider appropriate, having given public notice of the intended purpose and effect of the order, and having considered any objections and representations made to them, all in accordance with section 11(2) of the Act, hereby make the following order:-

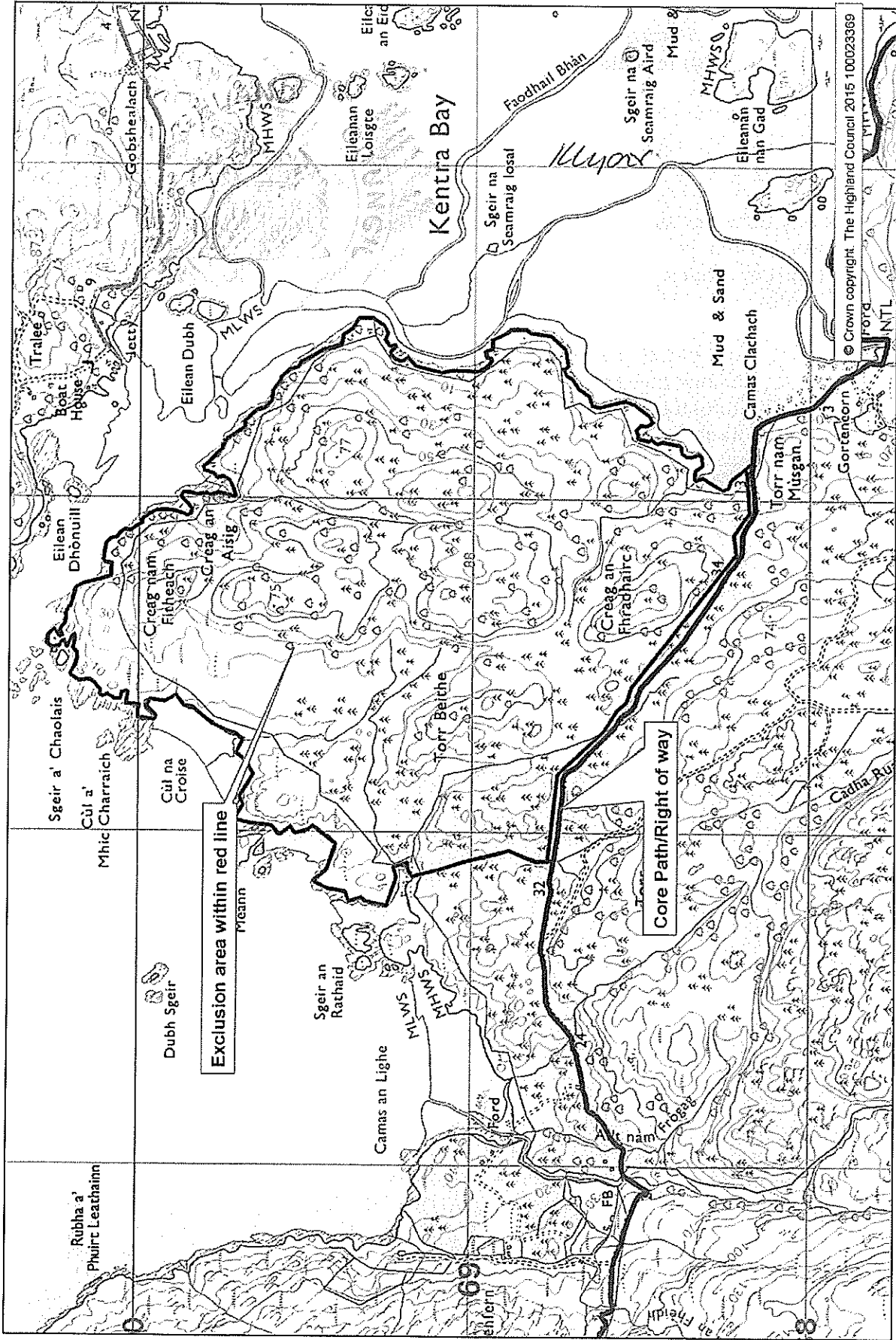
1. This order may be cited as The Land Reform (Scotland) Act 2003 (Highland Council) (Gorteneorn-Ardrnamurchan Estate) Order 2016 and shall come into operation during the period beginning at 0001hrs on 7 March 2016 and ending at 2400hrs on 20 March 2017.
2. The effect of this order is to exempt the land extending to 2.14km<sup>2</sup> (headland and forested area) at Ardrnamurchan Estate, Ardrnamurchan shown delineated in red on the plan annexed and executed as relative hereto from the access rights which would otherwise be exercisable in respect of that land by virtue of Part 1 of the Act.
3. The purpose for which the order is made is to film a TV series and all purposes related thereto including safety and security of participants, personnel and equipment.

**THE LAND REFORM (SCOTLAND) ACT 2003 (HIGHLAND COUNCIL) (GORTENEORN-ARDNAMURCHAN ESTATE) ORDER 2016**

I refer to your request of 10 February 2016 and your Council's subsequent submissions of 23 February 2016, 29 February 2016, 1 March 2016, 4 March 2016 and 23 March 2016, seeking confirmation by Scottish Ministers of the above proposed Order under section 11 of the Land Reform (Scotland) Act 2003.

You have confirmed that the Council has fulfilled the statutory requirements. The Council has undertaken the consultation requirements set out in section 11 of the Act on this application. The application was advertised by means of press advertisement in November 2015, with a formal consultation period of 4 weeks.

Thirty-five outstanding objections to the proposed Order were forwarded to the Scottish Government along with the Council's request for confirmation of the Order. The Scottish Government has considered those objections. The Council has also submitted the information requested in *The Land Reform (Scotland) Act 2003 (Modification) Order 2013 Guidance for Local Authorities and National Park Authorities*.
