## What are the site's constraints and how can they be resolved or reduced?

Historic Scotland. This is understood to be identified for its historic, landscape and archaeological association with the Battle. Neither the Council's policies or Historic Scotland's position discourage development in principle; both require the impacts of proposals to be assessed and mitigated. In this case, a comprehensive masterplan would be informed by a Landscape Capacity Study, a Landscape and Visual Impact Assessment and an Archaeological Assessment. The form and scale of development, its infrastructure and landscape context (and related mitigation) would derive from these considerations; and to that extent, the level of development within the Inventory Site.

In that regard, the allocation of land as presented in this representation is indicative:

The site is located at the edge of the Culloden Battlefield Inventory Site as identified by

In that regard, the allocation of land as presented in this representation is indicative: development is indicated to be held very substantially outwith the Inventory Site, but could overlap its boundary; open space uses could be located within the Inventory Site where these are found not to significantly affect its interest. The site involves 2.1 ha. of farm buildings and brownfield land to be redeveloped. This now appears to have brought within the Inventory Site further to Historic Scotland consultation without any explanation. A proposal at this location should be extended to fully embrace all land associated with the buildings necessary for viability as a first phase, given service connections and infrastructural improvements intended to accompany development and to ensure the replacement of derelict buildings. The site is part of Viewhill Farm that has been acquired for development. The farm extends to 100 ha. 80% of the farm is within the Inventory Site; the 20% of the farm outwith the Inventory Site is the focus of this development proposal, but a proportion of that land is considered unsuited for development for reasons other than to do with the Inventory

# What benefits will result to the wider community from the site's development?

(e.g. will there be more or better jobs, will the land be put to a more productive use, will the development increase infrastructure capacity for others, will more affordable houses result, is there an unmet demand for the development?)

The proposal comprises some 20 ha. of land adjoining the edge of the City and the existing urban neighbourhood at Balloch. It involves some 17 ha. of land with potential for housing, 0.2 ha. for community buildings/facilities and 1.5 ha. for open space and recreation. Balloch is identified in the adopted Local Plan as "homogenous" and deficient in housing mix and open space. Provision is made for extending the choice of residential accommodation and affordable homes, meeting requirements for community playing field and allotments, extending public transport in contributing to a better-balanced, more sustainable neighbourhood. The site is well screened from the B9006 tourist route and Culloden Battlefield by a strong treed edge in the margin of that route to the south. The site is well within the City altitude limits and offers potential for significant local enhancement and net environmental "gain" through the removal of an 11,000 sq. m "footprint" of large bulk agricultural buildings that are largely dilapidated and the redevelopment of 2.1 ha. of "brownfield" land.

The proposal will considerably enhance safety and traffic conditions on the C1028 Culloden

What impact will there be on travel patterns from the site's development? It will connect well with the wider Culloden "district" with links to the wider access network.  In strategic terms the proposal will extend the supply of land for expansion of the City not dependent on major infrastructure investment, support local education and community facilities and improve accessibility to facilities for the resident population of a large part of the existing community at Balloch. The proposal could be co-ordinated with the development potential of land east of the C1028 Culloden Road (Viewhill east) to give critical mass - and as part of an integrated masterplan in that context - but is not dependent on the allocation of that land  The site adjoins and would function with an established urban neighbourhood. In strategic terms the site would therefore be part of the structure of the City and accessible in that context to its services, employment and transport systems and to the evolving A96 economic development corridor. In that context, it is not likely to generate any significant change to the established patterns of movement. It may create sufficient critical mass to extend the existing bus service from Balloch; it will bring a wider range of community facilities within easier reach of the existing neighbourhood; it will involve improvements to footpath/cycle links to existing facilities
