

Dear Sirs.

Thankyou for the opportunity to put forward my small area of ground immediately to the North of Ardersier for Forward Planning consideration. I feel that situated where it is, it could be developed into a tremendous asset for our Community. It is obviously very early days but I would like to submit my "vision" for the following reasons. --

We have 100,000 visitors to Fort George. Campervans and Caravans park in every lay-by, the nearby Picnic Area and any Beach and Woodland parking opportunities that are available. In my opinion there appears to be a definite requirement for a Caravan/Camping site in this area.

I acknowledge that this is a area of certain natural beauty and would not wish to have too big an impact on this with my proposals. To this end I would like to involve any of the relevant bodies -- SNH, Highland Council ( John Orr, Local Countryside Ranger) Local Community Council etc in suggestions and ideas as to how we design this to best meet the needs of all.

It is adjacent to the Common between Ardersier and Fort George, which already has good Nature-Walks, Picnic area, information boards etc. It has the Storm Beach on the west side and is greatly used by **Wind and Kite Surfers**. On Health and Safety grounds alone these folks really need **changing**, **showering and toilet facilities** with some urgency. The toilet block for my proposed small Caravan site could also be able to accommodate them and would be designed having their requirements also in mind.

I recognise that nearby we have important Flora and Fauna. One of importance being the **Dingy Skipper** Butterfly. It requires certain flowers to lay eggs - - Birds Foot Trefoil and Horseshoe Vetch - - a certain element of scrub clearance is used in other areas to promote the growth of these flowers which in turn would help these Butterflies, perhaps this could be done on a small scale here. I feel that Nature Trails linked to the existing network close by, together with further information on all our Seaside Flora and Fauna could be a great enhancement.

A Managers Dwelling House/shop would obviously be a requirement and since we are inside the 30MPH area and there are houses already on the Eastern side of the B9006 perhaps if tastefully designed it would not be out of place.

I thank you again for considering this and am available at almost any time if you feel further discussion is required.
