Performance Report – Children's Services

Report by Director of Care and Learning

Summary

This report provides an update on the performance framework for Children's Services.

1. For Highlands Children 4 performance framework

- 1.1 Highland Council and NHS Highland have agreed a performance framework for children's services as outlined in *For Highlands Children 4*. This performance report is presented to the Education, Children & Adult Services Committee, as well as to NHS Highland.
- 1.2 All of the performance measures in the current framework have been allocated to *For Highlands Children 4* Improvement Groups.
- 1.3 A summary of the data is included at **Appendix 1**. Much of this data has been available and discussed at previous meetings of the Committee.
- 1.4 Commentary on new performance data which is either not on target or otherwise of note is detailed below.
- 1.5 There is further detail available on those indicators associated with the Child Health Commission in the subsequent assurance report.

2. Performance Data

- 2.1 Performance measure 103 concerns the number of early learning and childcare provisions who report that children have daily access to the outdoors. As the number of provisions changes over time, it is proposed that a more accurate measure would be to consider 'the percentage of provisions who report that children have daily access to the outdoors increases'. A similar change is proposed for measure 104, which would now read: 'The percentage of provisions that are able to provide free access to the outdoor increases'
- 2.2 Performance measure 95 concerns the number of eligible children supported to take up their early learning & childcare entitlement increases. This measure does not currently differentiate between the number of eligible two year olds from the number of eligible three and four year olds. The distinction is necessary as the eligibility criteria for two year olds is different to that of three and four year olds. It is proposed to change the performance measure 95 to read: 'The percentage of eligible three and four year old children taking up their early learning and childcare increases,' and to add an additional measure to read, 'The percentage of eligible two year old children (measured against the total population of two year old children) taking up their early learning and childcare increases'.

- 2.3 Performance measure 87 monitors the aspiration to reduce the delay in the time taken between a child being accommodated and a permanency decision being made. The decrease in months from a child or young person becoming looked after to matching continues to be very positive. The increase in the number of children registered for permanency waiting to be matched, and the reduction in the timescales, is evidence that work continues to reduce drift and delay which is contributing to this improvement.
- 2.4 Performance measure 85 considers the maintenance in the reduction of multiple exclusions in our schools. The latest year end data for 2015/16 shows a rise in the number of multiple exclusions from forty two in 2014/15 to fifty one. Analysis of this data has resulted in a number of areas of improvement work being undertaken, particularly within the Additional Support Needs improvement group. The group are working to update the advice and guidance provided to schools and are utilising ASN teams to support individual schools.
- 2.5 Performance measure 85 reflects the objective to reduce the exclusion rate for children who are looked after. The latest academic year end data shows this figure to have increased beyond the target of 155 to 182 exclusions. The service is currently conducting a small test of change in the Mid area led by the Care and Learning Manager, focusing on outcomes for Looked after children generally with a specific focus on reducing exclusions.
- 2.6 Performance measure 46 concerns the percentage of statutory health assessments completed within four weeks of becoming Looked After increasing. Completion of LAC health assessments within the 4 week timescale continues to be a challenge. This has been a result of young people being placed directly out of area, a number of young people refusing health assessments, and lack of capacity within the school nursing service during the summer holiday period. In November 2016, the appointment of a Nurse Specialist for LAC was made. This post has a specific responsibility for undertaking all initial health assessments for school age children and it is anticipated that this will have a significantly positive impact in ensuring assessments are completed within the four week time frame.

3. Implications arising from Report

- 3.1 There are a range of resource implications with regard to these performance indicators, but in most cases, performance can be addressed within current resources.
- 3.2 There are no legal, equality, risk, climate change/carbon clever, rural or Gaelic implications arising from this report.
