Thanks, as an initial stab here are my suggestions I may come back with more and happy to meet you and show you on map:

1. BA straight Tomich Road, Invergordon, both sides which are currently agricultural or industrially zones - change to industrial/retail/wholesale

2. Linear Park, Shore Road, protect and leave zoned as recreation/leisure, ditto the land beside ATS.

3. Railway Station, Invergordon, land owned by CFPA, re-zone housing/recreational.

4. Former Victoria garage, High St, re-zone housing, it might be industrial or housing at present.

5. Tank farm - re-zone housing, recreational/leisure or industrial, eg special or open use, VDLF presently working on this.

6. Davidson Drive, Inver, agric land owned by Achy, presently special use, re-zone to retail/wholesale or housing. 7. Some areas up by Newmore, Kindeace, Scotsburn, Achnagarron zone as housing, we can discuss later, thought is where there are small clusters of housing it should be allowed to expand to sustain the schools, similarly some areas at Ardross, discuss this.

8. Shore Road, remain as housing, the old car park owned by council.

PROBABLY others too, I need to come meet sometime and look at maps to think about Alness and Evanton, as they are not so imprinted in my brain as Invergordon.
