

The Highland Council Notice of Variation of Parking Charges 2018

Notice is hereby given that The Highland Council in exercise of its powers under Sections 35(1) and (3), 35(C) and 46(A) of the Road Traffic Regulation Act 1984 and The Local Authorities' Variation of Charges at Off-Street and Designated Parking Places (Notice Procedure) (Scotland) Regulations 1997 and of all other enabling powers to vary parking charges hereby makes the following variations to parking charges:

- (a) The Current Scale of Charges for parking in the Off Street Parking Places listed in Part 1 of the Schedule hereto is hereby varied to the New Scale of Charges as listed in the said Part 1 which parking charges are applicable on each day including Sundays.
(b) The Current Scale of Charges for parking in the On Street Designated Parking Places listed in Part 2 of the Schedule hereto is hereby varied to the New Scale of Charges as listed in the said Part 2 which parking charges are applicable on each day Monday to Saturday.
(c) The Current Fees or charges for permit parking, contract parking, season tickets and parking services within the Highland Council listed in Part 3 of the Schedule hereto are hereby varied to the New fees or charges as listed in Part 3 of the said Schedule.
(d) The Orders and Notices referred to in Part 4 of the said Schedule are varied in terms of this Notice.

This Notice and the variation of parking charges herein contained will come into force on 23rd April 2018.
