# Strathnaver Museum and the Bettyhill Café

# Consultation meeting 24<sup>th</sup> October 2017, 7pm, Bettyhill Village Hall

There were about 30 attendees including 4 Board members and Bob and Lindsay (current proprietors of the Café) – these 6 did not complete any of the questions below.

Attendees were split between 6 tables. Each table was handed three of the five question sheets to complete and took a little over ½ an hour to do so. (The sheets can be identified in this report by the CAPS LOCK headings).

Businesses represented at the meeting included proprietors and / or former proprietors of Bettyhill Hotel, Far Bay Inn, Bettyhill Café, Post Office, The Store. There was a marked sense that the businesses in particular recognised the need for the café to remain as a café – it was good for Bettyhill and good for their businesses: - if the museum does well, and the café does well, they will do well.

In plenary the following points/questions were also raised

- Surely Highland Council is required to put the property on the open market. The answer given to this was no.
- Please communicate results of consultation to residents
- NC 500 enhances the opportunities
- Consistent opening times was deemed essential and folk harked back to the days when a trip from Caithness or East Sutherland to the Café was a done thing.
- Suggested a Crofters themed lunch
- Money would be needed for furniture and fittings
- There was a call for a bigger plan for businesses to cooperate and maximise the opportunities presented by NC 500
- Lots of discussion around flood risks and insurance etc.

Responses to the questions are coloured.

## **KEEPING THE CAFÉ IN BETTYHILL**

If the museum takes on the café it will remain as a café and that is a good thing. What do you think of this statement, you might agree, or disagree or you may qualify your agreement (for example – *This would only be a good thing if....*)

- The museum would make a better job running the café
- This would be a good thing if the café hours linked with the museum hours including Saturdays
- Good thing if managed to ensure opening hours are adequate and consistent
- It is a wonderful idea for the Museum to take over the café and for it to remain as a café
- The café and museum worked in conjunction with each other when it was Elizabeths Café and kept to the stated opening times – both benefited

The Café keeps being flooded – (several times over the last few years) – this means Highland Council would find it difficult to find a buyer for the property and it is a good thing that the museum is willing to take it on because otherwise the building would quickly fall into disrepair.

The current flood alleviation seems to be working therefore less risk

- In the event of future flooding who would incur the loss?
- Since the last flood (5 yrs ago) major flood prevention has been carried out the risk is now minimal

One advantage of the museum taking on the building is that as a charity we should be able to raise funds to improve the building, including flood protection measures, to ensure the building remains in use.

## It would be good if the staff in the café were local volunteers

- Why? Not practical.
- Minimum wage should be paid to WORKERS
- Maybe it is too big a commitment for a voluntary approach
- Definitely not
- Restaurant work is hard. You cannot therefore depend on unpaid staff there may be none willing to work
- If the opportunity was available people could volunteer if they wanted
- If run by volunteers there needs to be some sort of commitment to ensure they cant pull out at the last minute

## What are the pros and cons of each the following approaches?

- The museum keeps absolute control and runs the café itself using a mix of paid and volunteer staff
  - o Maybe the volunteer staff should be confined to the museum?
  - Whoever gets it should keep it open 7 days a week
  - No, could be friction
  - o No, could be troublesome
  - o This could have an impact on the workload and expectations of the museum volunteers
- The museum keeps some control but leases the building to someone else to run the café
  - With stipulations in the lease regarding opening hours etc
  - Not sure
  - o YES
  - There could be interest in this proposition
  - o Best option
- The museum leases the building to someone else to run the café and lets them make all decisions about how the café is run
  - o NO

#### OTHER USES OF THE BUILDING

#### It is important that the 'Tourist Information" function continues in the building

- It is important that there is a tourist information centre in Bettyhill but not necessarily in the same building as the café. In fact, that would give more space for the café. (Maybe the Museum)
- Local People with Local Knowledge
- Tourist Boards in the village for out of hours
- Not necessary transfer to Telecentre
- TIC may be closed anyway, moving it would open up another room in the café.
- Yes very if it is a reason for visitors to the area to stop
- Yes most important that the TIC continues it benefits the whole community

## It is important that the Café continues to sell local crafts

- It is important that the community has a place to sell local crafts:-
  - O What about a local pop-up craft fair or market?
- At the discretion of the manager?
- What additional crafts could be offered
- Selling crafts means greater diversity of business a good thing reduces dependence on a single line of business
- Museum sells local crafts More space may be available with fewer items in café
- Alternatively, both outlets could carry different stock/similar items
- YES of good quality eg weaver.
- Space may be better used for café purposes
- Is there opportunity for crafts to be moved to the museum?
