296	Kinellan Burn	Adjacent to A834, upstream of St Anne's Episcopal Church	04/08/2018	New screen arrangement to be designed and installed at culvert inlet to replace existing damaged screen.
354	Lochalsh Burn 5	Kyle of Lochalsh	24/03/2019	Footbridge Culvert has partially collapsed restricting flow in the burn and causing overtopping upstream. Land ownership uncertain.
454	Clachan Burn	Bettyhill	15/08/2018	Build up of gravel and sediment to be removed, vegetation within watercourse to be removed
462	Ault na Skiah	Castle Heather Park by B8082	03/09/2018	Silt trap is full and requires material to be removed.
512	Rainbow Burn	Bruce Gardens, Fortrose	24/05/2018	Sections of culvert to be cleared of roots.
513	Kings Burn	Junction of Lower Wards and E Watergate, Fortrose	24/05/2018	Section of culvert to be cleared of roots.
529	Knightswood Burn	A870 at the junction with Auchingale Place Watten.	14/11/2017	The Invert levels of the ditch have risen due to vegetation and silt deposition. Return ditch to original invert level to help mitigate flooding on to the roads.
532	Lochalsh Burn 4	Church Street, Kyle of Lochalsh	22/09/2018	Replace section of collapsed stone culvert with 400mm diameter pipe.
537	Allt na Laitch	A862 prior to the Mineral Bridge	18/06/2018	Remove all vegetation and silt and stones which have accumulated in front of the screen, clear the culvert outlet to a point 10m downstream this will allow any silt which has accumulated within the culvert to wash out
540	Parks Farm Burn	Outlet of the Parks Farm Burn in to the Druid Temple Burn at the Grebe Avenue Hall	07/07/2018	Secure the chain to the screen which has been removed.
542	Allt Beag	A862 nearer to the property Coul na Mara than the Mineral Bridge	18/06/2018	Clear the outlet area of the culvert and reinstate the burn to its original invert level for a distance of 10 metres downstream from the culvert outlet
544	Dingwall Flood Defences	Possibly the Birches on Craig Road	01/07/2018	Clear and expose culvert inlet clear drainage ditch 10m upstream from inlet. Clear and expose culvert outlet and clear ditch 10m downstream
549	Scretan Burn Trib 3	Behind 1 Brinkman Terrace	12/09/2018	The culvert is blocked and requires clearing this is not an urgent job as there is an overflow channel
551	Culduthel Channel	Interface with the SWFRC near Culduthel Mains Circle	21/09/2018	Remove vegetation which is partially blocking the culvert inlet and forcing water to flow into the SWFRC
552	Lochardil Burn	Lodge Park	02/07/2018	Remove all vegetation which is blocking the watercourse in the Lodge Park area.
553	Dell Burn	Screens at Golden Bridge near to the A9	06/07/2018	Please remove debris and rubbish and vegetation cast aside from screen clearance
555	Bayview Burn	Between the property Bayview and the Electrical Sub Station East Bay Mallaig	18/06/2018	Remove large lump of concrete from the culvert inlet, remove screen.
556	Ashburn	Either side of the footbridge on Campbell Court, Ross Place	21/08/2018	Please removed vegetation which has been dumped into the watercourse on Campbell Court
557	River Peffery Trib 3	Docharty Road Dingwall	21/08/2018	Please remove the tree from the middle of the burn and clear the burn back to the original culvert invert level to a point 10m downstream from the culvert outlet
