# New for 2019/2020 - Practice Days

We have added three Master Classes in the form of Practice Days to our new calendar. These are full day intensive courses for the following topics:

- MARAC in Action
- Working with Children and Young People Affected by Domestic Abuse
- Working with Perpetrators to Promote Safety

These are primarily aimed at staff working directly with people affected by these issues and will provide practical skills training to support you in your work.

All training is provided free of charge. We will provide Tea and Coffee where possible and participants should make their own lunch arrangements. Please note that we may impose a £30 charge for non-attendance without prior notice.

#### **Violence Against Women Training – Aims & Learning Outcomes**

#### **Overall Aims of all VAW training**

- Increasing understanding of Violence Against Women as both a cause and a consequence of gender inequality
- Recognising the impact of VAW on individuals and on wider society
- Improving practice responses to VAW
- Develop and share best practice including approaches and practical tools

# **Level 1 – Understanding Violence Against Women and Gender Inequality (½day)** Participants can:

- Explain why Violence Against Women is a product of gender inequality
- Describe the many forms of Violence Against Women and describe how these are interlinked
- Discuss how the effects of experiencing the forms of VAW are broadly similar
- Give examples of policies to support staff to respond to VAW
- Illustrate their own role and the role of other organisations in supporting those affected by VAW

# Practice Day - Working with Children and Young People Affected by Domestic Abuse Participants can:

- Illustrate the impact of domestic abuse on CYP (Children and Young People)
- Illustrate challenges for practitioners and potential impact on child –centred support and assessment
- Illustrate approaches to managing safe contact
- Explain the Safe and Together approach
- Implement safety planning tools
- Implement a range of practical tools supporting engagement with CYP impacted by domestic abuse

# Practice Day - MARAC in Action inc Risk Assessment and Effective Information Sharing Participants can:

- Explain the historical context, purpose and aims of MARAC
- Illustrate risk factors in relation to high risk domestic abuse
- Illustrate a range of responses to disclosure of domestic abuse
- Explain MARAC processes
- Implement risk assessment and referral tools

#### **Practice Day - Working with Perpetrators to Promote Safety**

### Participants can:

- Explain the perpetrators code
- Illustrate the Caledonian Approach adopted in Highland
- Consider challenges and barriers for practitioners
- Implement approaches to holding perpetrators to account
- Consider a range of tools to support practice

#### Supportive Responses to Violence Against Women (1/2 day)

Participants can:

- Demonstrate asking about Violence Against Women issues routine enquiry & suspicions
- Demonstrate supportive responses to disclosure
- Carry out risk assessment and initial safety planning discussions (includes MARAC assessment & referral)
- Analyse how service responses can increase risk & assess how to mitigate these

### **Violence Against Women - the Traumatic Impact (1/2 day)**

Participants can:

- Explain what experiences might lead to psychological trauma
- Describe the differences between Type 1 and Type 2 trauma
- Illustrate the impact of experiencing trauma
- Implement approaches to enable a Trauma Informed Service
- Implement supportive responses to those affected by trauma

#### Perpetrators of Domestic Abuse (1/2 day)

Participants can:

- Explain a perpetrators 'code'
- Outline how the 'code' can be challenged
- Analyse the perpetrators tactics in order to promote safety
- Demonstrate good practice when working with perpetrators of domestic abuse

### Children's Experiences of Domestic Abuse (½day)

Participants can:

- Explain the of impact of domestic abuse on a child/young person at key development stages
- Discuss how the Highland Practice Model can be used to support children and young people affected by domestic abuse, and their families
- Apply models of working to increase perpetrator visibility & promote safe contact
- Analyse own practice in responding to children and young people with experience of domestic abuse

## The Impact of Rape and other forms of Sexual Violence (1/2 day)

Participants can:

- Demonstrate understanding of the different forms of sexual violence
- Illustrate the concept of 'consent' in relation to sexual relationships and sexual violence
- Discuss the myths and realities of Sexual Violence
- Illustrate interventions which can promote recovery from Sexual Violence

#### VAW Update: Refresher for Routine Enquiry & MARAC (1/2 day)

Participants can:

- Re-visit and reflect upon knowledge and understanding of violence against women and its impact
- Demonstrate an understanding of key themes in relation to Domestic Abuse
- Re-visit routine enquiry and reflect on best practice
- Re-visit risk assessment and safety planning and demonstrate approaches
- Re-visit key aspects of Multi Agency Risk Assessment Conferencing (MARAC) process and implications for practice

#### E learning – NHS staff only

Two Violence Against Women modules are available on Learn Pro for NHS Highland staff. Staff in other agencies can access these through Learn Pro Community, for which there is a registration charge. The Highland Council is exploring the possibility to hosting these modules on its own elearning platform.

Please note that if you are required to attend mandatory Violence Against Women training, these modules are sufficient as refreshers only.

## **Gender Based Violence – Learn Pro emodule**

- Explain what is meant by gender-based violence
- Define the health impact of gender-based violence
- Describe the nature of a sensitive healthcare response to someone who has experienced such abuse
- Explain what needs to be recorded following disclosure of abuse
- Identify sources of community supports for survivors of gender-based violence
