ORDER TO EXEMPT LAND FROM ACCESS RIGHTS

THE HIGHLAND COUNCIL (SNOWMAN RALLY 2019) ORDER 2019

The Highland Council in exercise of the powers conferred on them by Section 11 (1) of the Land Reform (Scotland) Act 2003 ("the Act") hereby make the following Order:-

- 1. This Order may be cited as "The Highland Council (Snowman Rally 2019) Order 2019", and shall come into operation as follows, unless revoked earlier:
 - a. Meall Mor (Plan 1) at 07:00 on Saturday 9th February 2019 and shall expire at 14:30 on Saturday 9th February 2019;
 - b. Millbuie (Plan 2) at 07:00 on Saturday 9th February 2019 and shall expire at 15:00 on Saturday 9th February 2019;
 - c. Rogie (Plan 3) at 07:00 on Saturday 9th February 2019 and shall expire at 17:00 on Saturday 9th February 2019;
 - d. Boblainy (Plan 4) at 07:00 on Saturday 9th February 2019 and shall expire at 18:00 on Saturday 9th February 2019;
 - e. Glenurquhart (Plan 5) at 07:00 on Saturday 9th February 2019 and shall expire at 19:00 on Saturday 9th February 2019
- 2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. The effect of the Order is to exempt land, namely the five areas of Forestry Commission land at Meall Mor, Millbuie, Rogie, Boblainy and Glenurquhart forests which are to be used for car rally special stages on the Snowman Rally, each area being shown delineated in red on the plans, numbered 1 to 5, annexed and signed as relative to this Order, from the access rights which would otherwise be exercisable in respect of that land by virtue of Part 1 of the Act. Rights of way are not affected by this Order.


