

# The Highland Council Statutory Obligations and Civil Contingency responsibilities

The Civil Contingencies Act 2004 provides a legal framework that places a requirement on The Highland Council to:

- 1. Assess the risk of emergencies occurring and use this to inform contingency planning.
- 2. Put in place emergency plans.
- 3. Put in place Business Continuity Management arrangements.
- 4. Put in place arrangements to make information available to the public about civil protection matters and maintain arrangements to warn, inform and advise the public in the event of an emergency.
- 5. Share information with other local responders to enhance co-ordination.
- 6. Co-operate with other local responders to enhance co-ordination and efficiency
- 7. Provide advice and assistance to businesses and voluntary organisations about business continuity management.

This legislation identifies The Highland Council as a first responder along with the emergency services in an emergency/major incident situation. This will involve partnership working with the emergency services but in reality the role for The Highland Council is more prevalent in the recovery stage.

The Highland Council also has a number of statutory obligations that can be split into three categories:

- Statutory functions little discretion
- Statutory functions with discretion
- Discretionary functions

The Highland Council, as a member of the Highlands & Islands Local Resilience Partnership, is working with their partners to mitigate and respond to significant disruption arising from a reasonable worst case scenario FU exit.
