

**THE HIGHLAND COUNCIL (LOCHABER) (DISABLED PERSONS' PARKING PLACES)

Statement of Reasons for proposing to make the Order

The Council is of the view that the provision of enforceable Disabled Parking Places in the areas of road shown detailed in the Schedule 1 to the proposed order and the deletion of parking spaces which are no longer required in Schedule 2 to the proposed order promotes the proper use of disabled parking places in compliance with the requirements of the Disabled Persons' Parking Places (Scotland) Act 2009.

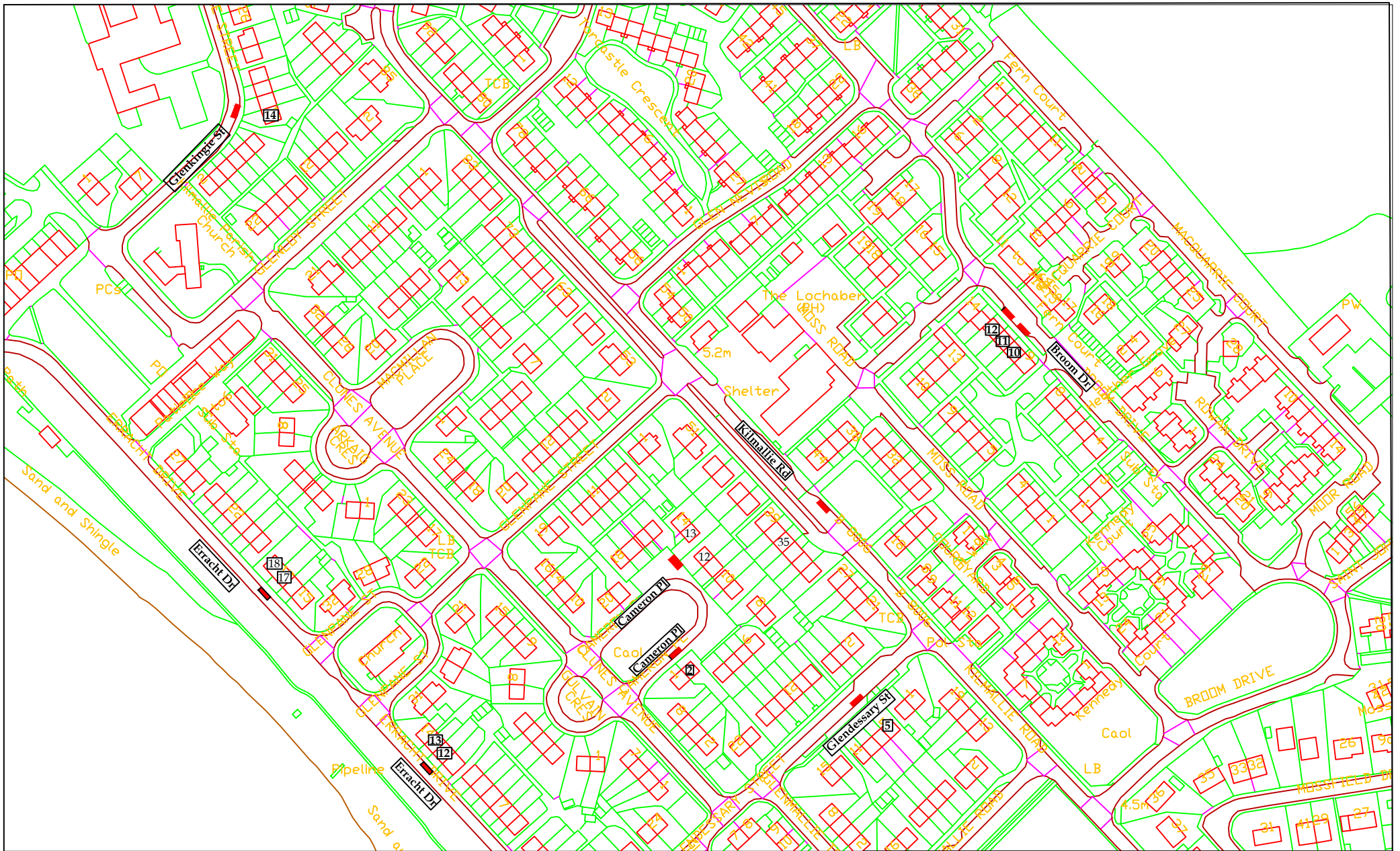
