### THE HIGHLAND COUNCIL (CORONAVIRUS) (AVIEMORE) (TEMPORARY 20MPH SPEED LIMIT) ORDER 2020

NOTICE IS HEREBY GIVEN that The Highland Council (CORONAVIRUS) (AVIEMORE) (TEMPORARY 20MPH SPEED LIMIT) ORDER 2020 has been made under Section 14(1) of the Road Traffic Regulation Act 1984 as amended. The Order, which has a maximum duration of 18 months, will come into force at 0600hrs on 21 December 2020. While the Order is in force, the restrictions will apply 24 hours a day. The Order is required to maintain social distancing and ensure public and road safety while Coronavirus restrictions are in place. The Council will keep the situation under review and will only revoke the Order before 18 months have elapsed if it considers that the restrictions are no longer necessary. If the Council decides to revoke the Order, this will be publicised prior to the restrictions being lifted

When this temporary Order comes into force, it will introduce a 20mph speed limit on the following roads in Aviemore over their entire length, unless stated otherwise below:
