To whom it may concern,

I am writing to you in my position of Secretary of the Heart of Sutherland Tourism group (HOST). We were formed in 2015 to promote not only the central area within the NC500 route for tourism but also the businesses that are located here tourism related or not.

Since the launch of the NC500 and its increasing success many visitors are now looking to explore other areas and find more quiet peaceful locations away from the popular route. The central area with its quiet roads, wide range of accommodation, interesting shops, and cafés/restaurants and off the beaten track hidden gems is becoming more popular. Many now use it as a base to explore much of the Norther Highlands on daily car tours without the need for changing accommodation every night.

During the Covid -19 restrictions on overseas travel has meant the Scottish Highlands has become a popular staycation location, and there are ever increasing numbers of motorhomes that are exploring the area. What the crisis has also revealed is that the lack of infrastructure for motorhomes has put a huge strain on local communities from inconsiderate camping, increased litter, and issues with disposal of human waste. Traditional campsite do not cater for the needs of modern motor homers who are looking for the more Aire type stopping points found around Europe which offer parking, facilities for waste disposal but are close enough to towns for supplies and to use local shops & café.

The site in Bonar Bridge has been used as an unofficial camping stop for many years and is the perfect location to be developed to provide additional facilities. With public toilets and the infrastructure of water and electric already in place this has reduced the investment costs to improve the facilities. The welcome addition of electric charging points for cars and bikes, sales of which are on a dramatic rise, will also help to boost its use as a base and give people the chance to explore the adjacent towns/villages of Lairg and Rosehall and provide increased trade to the businesses and activity providers in the area. It will also provide an income stream for the local area that can be reinvested into future development

As a group we whole heartedly support any development that increases the use of the area for tourism and the boost to the local economy that it brings. Therefore, we are happy to support the Kyle of Sutherland Development Trust in this development and hope that you will look favourably on their funding application.

Kyle of Sutherland Tourism Infrastructure Project

As Chair of the North Highland Initiative I am happy to give my full support to Kyle of Sutherland Development Trust's project to develop infrastructure to support the sustainable development of overnight motor home parking in Bonar Bridge, Invershin and Rosehall.

There has been a lot of publicity recently about irresponsible tourism and unacceptable behaviour by some visitors since lockdown was lifted in July. This has impacted on all the communities across the Highlands and Islands. Projects such as the one being developed by KoSDT will provide better facilities for visitors whilst at the same time reducing issues such as increased waste and impacts on parking and pressures on local services.
