296	Kinellan Burn	Adjacent to A834, upstream of St Anne's Episcopal Church	16/12/2020	New screen arrangement to be designed and installed at culvert inlet to replace existing damaged screen.
354	Lochalsh Burn 5	Kyle of Lochalsh	29/12/2020	Footbridge Culvert has partially collapsed restricting flow in the burn and causing overtopping upstream. Land ownership uncertain.
454	Clachan Burn	Bettyhill	19/08/2021	Build up of gravel and sediment to be removed, vegetation within watercourse to be removed
529	Knightswood Burn	A870 at the junction with Auchingale Place Watten.	19/08/2021	The Invert levels of the ditch have risen due to vegetation and silt deposition. Return ditch to original invert level to help mitigate flooding on to the roads.
532	Lochalsh Burn 4	Church Street, Kyle of Lochalsh	11/04/2021	Replace section of collapsed stone culvert with 400mm diameter pipe.
540	Parks Farm Burn	Outlet of the Parks Farm Burn in to the Druid Temple Burn at the Grebe Avenue Hall	14/03/2021	Secure the chain to the screen which has been removed.
549	Scretan Burn Trib 3	Behind 1 Brinkman Terrace	04/03/2021	The culvert is blocked and requires clearing this is not an urgent job as there is an overflow channel
579	Culduthel Channel	Car Park next to Culduthel Mains Court,	25/03/2021	Culvert is surcharged the outlet is approx 75% surcharged due to deposition, ditch and return the outlet to the original level, Jetting may also be required to ensure the there are no blockages/silt deposits with the culvert.
580	South Kessock Seawall	3 Areas in the seawall	20/04/2021	Repair missing stones sets in the seawall
606	Slackbuie Channel	Between West Heather Road and Culduthel Road	02/03/2021	Block and fill in the offlets which have been cut into the banks of the burn diverting flow into adjacent low lying areas. Remove all woody debris which is blocking the burn.
608	Dingwall Flood Defences	Canal footpath At victoria park	01/03/2021	Infill and seal holes in the embankment where rabbits have been burrowing.
611	Dingwall Flood Defences	Canal footpath At victoria park	01/03/2021	Cut back and strim all vegetation growing in and along the flood embankment
613	Edderton Burn	Edderton, Edderton Bridge	03/03/2021	Clear/ remove tree trunk for under the road bridge
621	Slackbuie Drain	Morninfield Road and Lillybank	08/03/2021	Landowner and factors to arrange remedial work following flooding in october 2020
622	Auldearn Burn	Brig o Broom, Ientran	10/03/2021	Clear all sediment accumulations from the inlet and outlet and ditch 10m upstream from the inlet
624	Whaligoe Burn 1	Junction A99 road to Loch Watenan	27/04/2021	Remove blockage from within the road culvert. BEAR contacted and made aware of works required.
