3. Design Update

Our entire project team has been able to continue work on refining the internal and external layouts and design for the school. Everyone is managing to work from home and we have been using video conferencing to go over specific focus areas and discuss drawings and layouts.

Within The Highland Council team, we have continued to liaise with our internal Users Groups including staff in the Early Years and Teaching, Facilities Management, Catering, Safer Routes to School, school transport, and others.

The planned school opening date of August 2021 will not now be achieved due to the ongoing situation and we are reviewing the implications of this. However, our ability to continue to work during this period means that the project will be in a better position to resume once restrictions are lifted.

4. Planning Update & Planning Conditions

Work continues to be undertaken by the project team to assemble information to discharge the pre-commencement conditions. Planning permission for the school includes twenty-six planning conditions covering a full range of items, most of which are considered pre-construction requirements. As information packages are developed, we will coordinate with Planning for their approval and subsequent discharge of planning conditions.

5. Transition

As noted before, there is no information to report on this item which will become more relevant as we progress through the project. The head teachers of Holm and Lochardil primary schools, and specialist education staff continue to be involved in the design and development process.

6. Community Benefits

We continue to seek suggestions for possible community benefits that may be provided by the contractor team as part of the school project. Community Benefits is a key element of a major project of this kind and we are keen to identify any proposals. Selected proposals will be taken forward by a dedicated member of the contractor's team.

To date, Holm Primary School has identified a community benefit for their school. They have requested for some help with improvements to their outdoor play area for the pupils.

Also, Holm Community Council has requested that two free-standing display boards be located at the bus stop at the top of the main road entrance into the Ness Castle development and outside the school for the purpose of displaying community notices.
