Project Title: Socially Growing Greenhouses

Background

Thurso Community Development Trust has in two years established a recognised track record in the delivery of community growing and climate action projects. The Trust is still in its infancy, but its activities reflect a forward thinking and ambitious organisation who have quickly become a community anchor for Thurso and are recognised as a leading third sector organisation in Caithness and Highland. The Trust is now seeking to move in a direction away from sustained dependency on grant income and create social enterprises which have been identified from consultation to address identified community needs and which generate revenue which benefits the community.

Proposed Project & Activities

In mid-2020 as we entered the end of the first lockdown phase and were looking towards projects and activities to strengthen our organisation and provide recovery activities for Thurso we became aware that the Thurso Greenhouses Complex was no longer in use by Highland Council. The facility has had little to no investment in latter years yet with capital investment for repairs would be a significant opportunity for the Thurso community and Thurso Community Development Trust to realise aspirations in creating enterprises which assist the town in contributing to net zero carbon emissions by 2045 and addressing the need for holistic youth training facilities in the town.

Our proposed project is therefore to invest in the capital infrastructure of the Thurso Greenhouses Complex and make them operational again to be thriving Greenhouses which produce quality organic locally produced food. The food would produce an income through sales to the community and to local hotels and cafes. Promoting localism and resilience in our food chain.

In operating as a social enterprise there is the further benefit of providing youth training and employment opportunities. Consultation has found that Thurso has a number of young people who feel alienated from mainstream employment and education and require holistic and supported training and employment opportunities which give life, vocational and enterprise skills.

In tandem with the Greenhouses facility we are also developing the linked social enterprise (both operations will work in tandem with each other) of a Zero Waste Refill Shop and mini-hub in Thurso Town Centre. This facility will be in Thurso

precinct, 100m away from the Greenhouses and provide a site for our staff to be based and a shop where produce from the Greenhouses can be sold to the public along with workshop and training space in climate and land based activities. The Business Plan attached to the proposal outlines these further.

Socially Growing will create:

Extensive refurbished Greenhouses and a thriving social enterprise Youth Training opportunities

An events space for growing and climate based skills to be developed in the wider community

Volunteering opportunities

Local food production and promotion to reduce our carbon emissions Reinvestment of profits for community benefit

Objectives of Project

BUSINESS OBJÉCTIVES:

To make a long-term sustainable organisation achieving an annual surplus for investment in the community, it people and environment.

To offer the opportunity of purchasing locally grown organic food and plants to our community and communities further afield

To return a surplus per annum of circa £40,000 from the 'Socially Growing Hub & Greenhouses'

To offer event and workshop spaces which are self-sustaining and offer training and support to similar enterprises to grow economic resilience and diversity.
To improve and support our tourism industry and promote town centre regeneration.

SOCIAL OBJECTIVES:

To provide opportunity to those aged 16 - 26 years in the community for training in growing, horticulture, land and climate based social enterprise to empower them towards new Start Ups or further employment opportunities.

To empower the local community through the membership owning and managing assets and facilities and ensuring an open and fair structure that reflects community ownership.

To provide access to events, activities, training, education, informative and provide fun to the local community.

To build community connections, resilience and cohesion.

ENVIRONMENTAL OBJECTIVES:

To mitigate against the current Global Climate and Ecological Emergency by supporting the Thurso and wider Caithness Community to reduce carbon emissions through supply of locally grown food and zero plastic good and produce.

To continue to adopt environmentally friendly practices and minimise any negative impact on the environment.

□ To educate the community on climate – both mitigation and adaptation.

□ To encourage an increase in the community taking up climate action behaviours.

Benefits of the proposal

Economic & Regeneration

The Trust intends to commence operations of a social enterprise, "Socially Growing" within the Greenhouses facility. The social enterprise will produce revenue for community benefit. Taking an enterprising approach will decrease the Trust's dependence on grant funding and create wider community benefits by profits being reinvested back into the community. In addition to produce that we grow ourselves we will be providing an outlet for other small growers to come together in a cooperative movement in the supply of vegetable boxes which will create further economic benefits within the area. The training which will mainly be delivered from the facility will be for young people to gain holistic life skills and training in land and climate based skills with a particular emphasis on them gaining experience in running enterprises creating a more resilient and diversified economy with entrepreneurial skills developed in young people. The site while tucked away in Thurso Town Centre presents an opportunity for regeneration within an area which is often overlooked. Further economic and regeneration benefits will be available from visitors being able to tour working greenhouses and the community occupying the site and developing it for use as a thriving growing area. It is keenly felt that with little investment having been made in the facility in recent years that if the community does not have ownership of it the facility will be left to decay further and that taking it into community ownership for community benefit will encourage further regeneration in that area of the town. The Trust has also secured funding via Town Centre Regeneration Funding for Market stands and it is intended that the area of Olrig Street Gardens is used on an adhoc permissions basis to further regeneration in a prime location in the town thus encouraging additional footfall to the town centre and an impetus towards localism.

Environmental Benefits

The vision of the Highland Council Draft Food Growing Strategy is that, ""By 2025 Highland communities are resilient, empowered and supported to grown their own food." The Greenhouses facility will enable the community to become more resilient through locally grown food reducing the need for supply chains from further away and reducing the carbon emissions of the community. Not only will locally grown food which has been produced to permaculture principles of no fertilizers be available but food will not be wrapped in plastic nor any other consumables. Training offered will be predominantly to young people but training events will take place for members of the community assisting them to grow their own. A core part of the holistic training for young people will be working with the local community to improve greenspaces on project work with the community. This will enable environmental benefits to reach further into the community. It is intended through work with the Highland Good Food Partnership for this project to be an exemplar and example of best practice to other communities throughout Highland. The Trust has a core ethos of Climate Action and holds environmental policies and seeks to be a core contributor towards the Thurso community reaching net zero targets by 2045 through its work.

Health and Social Wellbeing

Food is a key source of health. The Greenhouses facility will produce food grown to permaculture standards and will seek to obtain accreditation as Organic food through the Soil Association scheme. Produce will be mainly for enterprise purposes but there will also be an agreement via our other projects of the Sharing Shed and our Community Meals service for produce to be used in these services. The facility will encourage health and social wellbeing through the workshops, events and training that it delivers. Social Wellbeing is also created through community empowerment. The facility will be owned, managed and run by the community with widespread community benefits from any profit that is incurred being reinvested back into the community. Growing and food are linked to social wellbeing and sessions will be run through the facility to empower and support health including provision of volunteering opportunities through social prescriptions and voluntary work to improve mental wellbeing.

Reducing Inequalities

Every young person in Thurso should be valued. Currently through our consultation we have found that for many young people this is not the case. Generational inequalities have led to many young people in the area not having a sense of hope for opportunity. They feel written off and go further astray into addiction, mental health issues and possible interaction with the criminal justice system. The facilities we are proposing will assist in reducing these inequalities by taking a chance on young people who feel ostracised from the system and opportunities to find work and education. Training through holistic methods of giving vocational training and life skills along with encouragement towards enterprise and entrepreneurship.

Restrictions on use of the land

Legal report outlines:

There is a deed from 1897 referred to for burdens and that deed provides that the only buildings to be built on the subjects of that disposition (ie Greenhouse area) are

dwelling houses, villas or shops and that if any such buildings are not erected then the land is to be used for gardening or similar but not pasturing, grazing cattle or keeping/raising poultry. There is a restriction on the land being used for brewery, tannery, foundry, chemical works, inn, tavern or shop selling alcohol without written consent of the Deacon's Court. These may not be enforceable and in any even do not prevent the use of area for Greenhouses etc.

The usage of the site is for Greenhouses and gardening and there are no plans to introduce any other facilities or services contrary to the deeds.

Negative consequences

The project has been developed in recognition of the success of an existing growing project and in recognition of the need to develop youth training facilities in the area. It will be managed and operated by the community with specific aims to reduce inequalities in the Thurso and wider Caithness area.

The project aims to create a more resilient, environmentally sustainable and lower carbon Thurso and fits with key aims to reduce carbon emissions and build resilience in the community.

Capacity to deliver

4.5 Please show how your organisation will be able to manage the project and achieve your objectives.

Thurso Community Development Trust is still a relatively new organisation but has amassed a significant track record in its 3 years since forming. Key to this success has been the ability to identify and evidence community needs and form this into suitable and realistic projects which benefit the community and take the community on a journey of empowerment with the organisation. Pertinent to this application is the Thurso Grows project which over 2 years through a lease arrangement with Highland Council has transformed the Community Garden Space at the bottom of Falconer Waters Court from an abandoned and overgrown space to a flourishing community garden with empowered volunteers and high levels of community engagement. We have an experienced Royal Horticultural Society qualified gardener and a further gardener who is qualified in permaculture. Our Board of Trustees consists of qualified professionals in adult education, environment and marketing. All are assisted by an experienced Development Manager who has a very significant background in finance, facilities management, funding, project management, addressing inequalities and sustainable development holding a BSc (Hons) Sustainable Development and BA Child & Youth Studies.

The Trust also has significant strong partnership working throughout the Caithness area and wider Highlands networks. We are a core partner in the work of the Caithness Resilience Group and Caithness Community Planning Partnership. We are also a core partner and pertinent to this project in the Highland Good Food Partnership. One of many projects being developed through the partnership is the use of 'Glasshouses' or Greenhouses to develop sustainable food systems in Highland and it is hoped this project will be a trial of this and act as an exemplar to establishing a further network throughout Highland. The Trust has also recently been selected by the Scottish Government to establish a pilot Climate Action Hub for the North Highlands operated from Thurso and this project will be complimentary to the work in the Greenhouses.

Thurso Community Development Trust

The Trust has the core aim of making Thurso a better place to live, work and visit through sustainable community led development. The Trust operates on a basis of community evidence of need to inform and develop projects. In 2018 using the Place Standard methodology widespread consultation was carried out in the Thurso area to identify the needs of the community. 1180 responses were received, 20% of the adult population of the town. This consultation work continued throughout 2019 where specific engagement was carried out within those experiencing inequality in Thurso with consultation work feeding into the Caithness Community Planning Partnership and the emerging Thurso Locality Plan.

To date the projects of the Trust include:

Thurso Grows – funded by the Climate Challenge Fund, a community garden space which encourages local food growing and food waste minimisation. This project has engaged through events, workshops and activities 2,153 members of the Thurso Community.

Discover Thurso – a community led tourism development project creating destination marketing website and associated social media along with a tourism development plan. Through this project over 300 members of the community were trained in the art of delivering tourism information to visitors and working collaboratively.

Community Support – From March 2020 and still currently being run is our Covid-19 Community Support efforts where we have assisted over 600 members of the community in the Thurso, Halkirk and Caithness West Community Council areas with shopping, prescriptions, errands and a continued meals service. We have delivered over 15,000 hot meals and continue to do so on a weekly basis.

The Sharing Shed – reducing food waste in Thurso by redistributing surplus food through a community larder.

Thurso Community Magazine – produced quarterly with a circulation each quarter of 1,500 reaching those in the community who do not have online access to share community news and as a community anchor for the town share information on other third sector and voluntary organisation.

Thurso Harbour Toilets – The Trust operate these on a donations scheme for the benefit of the community and visitors to the area.

In addition to this the Trust are currently gaining further skills and experience in developing other projects in the town including exploring the feasibility of the Drill Hall, Sinclair Street, Thurso as a community hub for the town, an identified priority need and are in the process of moving offices to one in the town centre which will also accommodate and Zero Waste Refill Shop and workshop space.

Initial Community Consultation in 2018 which formed the basis of the Trust Strategic plan informed the organisation that the local Thurso Community wanted to see greater effort made in local food particularly in growing and skills to be shared throughout the community. This initially involved suggesting purpose for the Old Auction Mart Site next to Thurso Railway Station as a large Greenhouse and community growing facility with orchard. However, it was known to the organisation that this area of land was to change hands to a developer.

In September 2018, the Trust were approached by Caithness Biodiversity Group regarding the 'Bee Bubble' Garden at the bottom of Falconer Waters Court. Significant consultation was made within the community to take over this asset and form a Climate Challenge Fund project with assistance from a Development Grant

from Climate Challenge Fund. This project has been running successfully now for 2 years and evidence and support within the community is abundant in the need to extend. Over Summer 2020 the Trust established a takeover of Sir John's Square Gardens in the centre of Thurso planting vegetables to replace the flower order of Highland Council cancelled due to Covid. Widespread support for this project was evidenced and having the knowledge that the Greenhouses Facility was no longer needed by Highland Council gave us the ability to engage with those who were attending volunteer and pop up market sessions in the Square. Of those we discussed the project with 100% were in favour of extended growing spaces and would purchase both vegetables and plants from a social enterprise specialising in this service locally.

In September 2020 we conducted a survey into Climate Action in Thurso, results attached, evidencing community need and support for the project. Several social media posts have achieved widespread support including a video posted from the Greenhouses on 21st November 2020 which engaged with 1,200 members of the community. A further Member's Meeting (which is open to all not only Member's of the Trust was attended by 49 people within the community and all voted to establish the project.

Consultation in 2019 specifically with Young Men in the Thurso area found evidence of inequalities and a lack of hope amongst young men in particular with mental health, addiction and lack of job and training opportunities evident. The project is born out of a need to for our community to be more resilient and to build local food chains in the face of Climate Change but more specifically it is to give training opportunities and holistic care and support to people within the community like these young men who do not enter well into mainstream employment and training. Assisted whole life skills support will be given to them. Covid-19 Recovery Surveys in 2020 revealed significant concerns across the community that there were now a lack of opportunities for young people and that mental health was a priority. Due to the Caithness Cares (Mental Health Pathfinder Project) currently being run in Caithness we have engaged again with the young men who we spoke to in 2019 and engaged further across the community and all would support initiatives such as this. The greatest need that these young people have is for someone, an organisation to place value on them and support and engage with them while providing an opportunity.

Section 6: Funding

Thurso Community Development Trust will pay the £1 nominal lease from unrestricted reserves.

This project represents the adaptation of the Trust from an organisation dependent on grant income to one which generates income for the benefit of the community. In order to refurbish the Greenhouses capital investment is required. The proposed facility will run alongside a Zero Waste Refill Shop which will enable the sale of produce therefore the funding applications are linked. Three funding applications have therefore been made to refurbish facilities and provide capital and revenue investment for the first 18 months of operation.

Crown Estate Coastal Communities Funding

A total grant of £77,376 has been applied for this includes capital investment in the Greenhouses complex and also the associated Zero Waste Refill Shop. The breakdown of the budget is attached in a budgets record and the Business plan for Socially Growing Greenhouses and Shop is attached.

Scottish Government Adapt & Thrive

A total of £55,000 has been applied for which will mainly supplement staffing costs over an 18 month period particularly that of the Gardener and the Enterprise manager who will have the duty of managing the refurbishment of the Greenhouses facility.

Refurbishment of the Greenhouses includes: Replacement of Polytunnels Repair to existing polycarbonate sheeting on greenhouses Levelling of paths Repair and renewal of heating system. The heating system currently in place will be repaired but we plan to work with Interface and secure an academic partner to look at alternatives for heating which are low carbon and deal with waste innovation to heat the greenhouses in the longer term. Repair to sheds including collapsed roof.

Replacement doors on all greenhouses

Repair to toilet facility Initial equipment purchases including tools, seeds and trays. Refurbishment of one Greenhouse to accommodate an events space.

Should either of these funding bids fail the Trust has a secondary plan to apply for alternative funding to Baille and Stroupster Wind Farm who have both expressed an interest in the project if current funding bids fail. As we are establishing a social enterprise we will also consider social enterprise loan funding towards capital costs. We also have the support of Highlands and Islands Enterprise who will account manage the social enterprise and have confirmed assistance will be given for any funding shortfall.

Some work is being done 'in kind' via volunteers for the simpler tasks of painting and replacement of polycarbonate sheeting while for other work we will employ the work of local contractors.

It is the intention that revenue will be generated quickly from the site. One Greenhouse is ready to plant in immediately with others coming on stream as others are refurbished. The attached Business Plan for Socially Growing Greenhouses and Shop outlines the plans for the social enterprise. Income can be generated immediately via wholesale fruit and vegetable boxes operating from the site supplemented by produce as it becomes available. We have spoken to local hoteliers and cafes who express interest in the business and purchasing from it. There is no displacement to be considered as no business exists in Caithness akin to Socially Growing other than Caithness Summer Fruits and soft fruits will not be grown in the Greenhouses.
