THE HIGHLAND COUNCIL PROPOSE TO CONSTRUCT 2 SETS OF CHICANES ON U1124 CAUFIELD ROAD AND A RAISED TABLE WITH UNCONTROLLED PEDESTRIAN CROSSING ON U5096 CASTLEHILL DISTRIBUTOR ROAD, INVERNESS

NOTICE IS HEREBY GIVEN that **The Highland Council**, in terms of the powers contained in section 36 and 39A of the **Roads (Scotland) Act 1984** as amended, The Roads (Traffic Calming) (Scotland) Regulations 1994, The Road Humps (Scotland) Regulations 1998 and of all other powers enabling them in that behalf propose to construct 2 chicanes on the U1124 Caulfield Road, Inverness and a raised table uncontrolled pedestrian crossing on U5096 Castlehill Distributor Road, Inverness as follows:

- Chicane North 90 metres or thereby West of the U2957 Towerhill Avenue, U1124 Caulfield Road Junction, Inverness
- Chicane South 138 metres or thereby Northeast of the U5096 Castlehill Distributor Road, U1124 Caulfield Road Junction, Inverness

Both chicanes consist of 2no. build outs constructed on alternating sides of the carriageway with 1.2m wide cycle bypasses. The length of each build out is 6.8m and width of 1.92m, the Southbound carriageway width is reduced to 4.0m and the Northbound carriageway width is reduced to 3.9m. Road signs and road markings will be installed as per the Traffic Signs Regulations and General Directions 2016. Priority is given to vehicles travelling away from the centre of the Village.

• Raised table with uncontrolled pedestrian crossing will be located 27 metres or thereby Southeast of the U5103 Castlehill Gardens, U5096 Castlehill Distributor Road Junction, Inverness

This raised table will be 75mm in height (max) across the carriageway kerb to kerb (6m wide). It will consist of a raised section (75mm in height) 3000mm long and two tapered ramps located on each side 1125mm wide.

In terms of Section 7 and Schedule 6 Part 3 paragraph 9 of the Coronavirus (Scotland) Act 2020, the Council has decided not to make the schedule and plans available for public inspection or publicise them other than by electronic means because to do otherwise may give rise to a significant risk of the transmission of coronavirus.
