THE HIGHLAND COUNCIL PROPOSE TO CONSTRUCT 3 SINGLE SPEED HUMPS WITH BUILDOUTS, 2 SETS OF SPEED HUMPS AND 2 RAISED TABLES WITH UNCONTROLLED PEDESTRIAN CROSSING ON C1119 CARRBRIDGE – MULLUCHARD – BALNAAN ROAD, CARRBRIDGE

NOTICE IS HEREBY GIVEN that **The Highland Council**, in terms of the powers contained in section 36 and 39A of the **Roads (Scotland) Act 1984** as amended, The Roads (Traffic Calming) (Scotland) Regulations 1994, The Road Humps (Scotland) Regulations 1998 and of all other powers enabling them in that behalf propose to construct 9 single speed humps with buildouts as well as 2 sets of speed humps on the C1119 Carrbridge – Mulluchard – Balnaan Road in Carrbridge as follows

- 30 metres or thereby east of centre line of the junction with the B9153 road
- 88 metres or thereby east of centre line of the junction with the B9153 road
- 147 metres or thereby east of centre line of the junction with the B9153 road
- 209 metres or thereby east of centre line of the junction with the B9153 road
- 276 metres or thereby east of centre line of the junction with the B9153 road
- 330 metres or thereby east of centre line of the junction with the B9153 road
- 392 metres or thereby east of centre line of the junction with the B9153 road
- 434 metres or thereby east of centre line of the junction with the B9153 road
- 504 metres or thereby east of centre line of the junction with the B9153 road
- 50 metres east of the centre of the U2171 Carr Place junction, Carrbridge.
- 137 metres west of the centre of the U2171 Carr Place junction, Carrbridge

Aswell as a single speed hump on Rowan Park (U3203)

• 107 metres of thereby south west of junction with the C1119 road.

The Build-outs Uncontrolled Pedestrian Crossing is a narrowing of the existing carriageway to 3.6 metres wide. The total length of the build out is 2.440 m flushed to the edge of carriageway. Width of build out is varies due to existing carriageway.

The proposed speed humps are 75mm in height (max), 1600 mm wide and 1900 mm in length.

• Raised tables with uncontrolled pedestrian crossing will be located 50 metres east and 137 metres west of the centre of the U2171 Carr Place junction

This raised tables will be 75mm in height (max) across the carriageway kerb to kerb (6m wide). It will consist of a raised section (75mm in height) 6000mm long and three tapered ramps located on each side 1125mm wide.

In terms of Section 7 and Schedule 6 Part 3 paragraph 9 of the Coronavirus (Scotland) Act 2020, the Council has decided not to make the schedule and plans available for public inspection or publicise them other than by electronic means because to do otherwise may give rise to a significant risk of the transmission of coronavirus.
