

**THE HIGHLAND COUNCIL**  
**PROPOSE TO CONSTRUCT BUILD OUTS (ROAD NARROWING) ON C1121,**  
**TOMATIN**

NOTICE IS HEREBY GIVEN that **The Highland Council**, in terms of the powers contained in section 39A of the **Roads (Scotland) Act 1984** as amended, The Roads (Traffic Calming) (Scotland) Regulations 1994, and of all other powers enabling them in that behalf propose to construct 2 build outs (road narrowing's) on the C1121 Tomatin as follows:

- 109 metres or thereby North of the U2944 School Road, C1121 Junction, Tomatin.

The road narrowing is on both sides at the same position along the carriageway by constructing build out 1.0m wide flushed to the edge of existing footpath at the west side of the carriageway with 125mm upstand. Part of carriageway is removed and replaced with kerb build out 1.0m wide at the East side of carriageway with 125mm upstand. The build out is 11.9m in length reducing the carriageway width to 3.6m. Road signs and road markings will be installed as per the Traffic Signs Regulations and General Directions 2016. The priority established at this feature mean that vehicles travelling toward the Village will have to give way to vehicles travelling in opposite direction.

- 82 metres or thereby Southeast of the U2894 Old Mill Road, C1121 Junction, Tomatin.

The road narrowing is on both sides at the same position along the carriageway by constructing build out 1.4m wide flushed to the bridge parapet at the west side of the carriageway and build out on the East 2.1m flushed to the bridge parapet. The build out has 125mm upstand and is 13.8m in length reducing the carriageway width to 4.0m kerb to kerb. Road signs and road markings will be installed as per the Traffic Signs Regulations and General Directions 2016. The priority is given to vehicles travelling toward the Village.

In terms of Section 7 and Schedule 6 Part 3 paragraph 9 of the Coronavirus (Scotland) Act 2020, the Council has decided not to make the schedule and plans available for public inspection or publicise them other than by electronic means because to do otherwise may give rise to a significant risk of the transmission of coronavirus.
