**At This time** the Berriedale and Dunbeath Community Council does not support the application by Dunbeath & District Centre to acquire the land south west of 9 Neil Guinn Rd.

In 2016 the community council looked at purchasing the land with a view to extending the sheltered housing availability given the long term ageing population. The Highland Council put a number of conditions on the purchase and the only organisation that satisfied those conditions was the Dunbeath & District Centre so we asked them to investigate the possibility. The last we heard was they were looking at the FIT system as practised in Invergordon.

On the 6<sup>th</sup> September I was sent by a member of the public a link to a survey. I looked at it on 7<sup>th</sup> September and forwarded it to the members on the 8<sup>th</sup> September. When they went to look at it it had been taken down. I asked for a copy of the survey but did not receive it. I then put on the next Community Council agenda "housing at Achorn Rd". On the 2<sup>nd</sup> October the Saturday before our meeting on the Monday we received a 26 page business plan for a new centre on the land at Achorn Rd.

On the 5<sup>th</sup> October we received a request to write a letter of support for the project. On talking to members of the public the community councillors discovered that most people other than centre users knew nothing about it. We then wrote to the centre and asked them to give a presentation to a public meeting before the community council meeting on 1<sup>st</sup> November. They declined.

In their letter declining to give a presentation they talk of it having been a managed and inclusive process. It has been a managed process but it as someone said has been done under the radar and mainly their users were the people that knew about it. The second half of that sentence more accurately reflects their viewpoint when they say they will inform the general public of their plans at their convenience.

As a result it is the view of the Community Council that the land should not be transferred to the Centre until a proper community debate about the plans has been undertaken and that probably independent outside consultants should be taken in to assess the communities views on the project.
