I write on behalf of my family (2adults and 1 child, 1 teenager and an OAP).

We all use the centre weekly and would be lost without it, the staff go above and beyond to make every feel welcome no matter who they are.

The library is fantastic for my teenager as there is no book shops up here in Caithness. The sharing shack has helped me out when I was furloughed from work. We had the weekly family meal which was thoroughly enjoyable and a weekly treat as we did not go out anywhere. I enjoy the Pilates class which is great for my mental and physical health.

My elderly mum enjoys the centre and attends regularly as it is the only opportunity she has to see other people.

If a new facility is built it will be fully supported by myself and my family and we will all look forward to attending more events to improve our health and well-being.



Upon retirement I moved from the South to settle in Dunbeath and have been a User of D&DC for over 11 years. Without D&DC my social life would be virtually non-existent as it is the only place in South East Caithness where I can meet and socialise with other members of the community through various activities.

The activities I participated in prior to Lockdown included

- Weekly singing group
- Weekly walking group
- Monthly Bingo evenings
- Monthly Whist drives
- Weekly Board game evenings (Chess, Scrabble, Ludo etc.)
- Computer classes for beginners (6 week course)
- Daytrips & Sightseeing Tours (3 or 4 annually)
- Weekly Reflexology Session (One on one treatment)
- Daily lunches (available 5 days per week. I attended 2 per week)
- Weekly Dinner night

I also know that D&DC provide the following activities to other Users

- Cookery Classes (both for adults and teenagers)
- Craft classes
- Art classes
- Yoga Sessions
- Pilates Sessions
- Mindfulness Sessions
- Hairdressing
- Hearing and Sight Clinic (Quarterly)
- Breakout room for Dunbeath Primary School
- Hairdressing (weekly)
- Laundry Service
- Well Stocked Library (books, Cd's DVD's)

Although D&DC activities ceased during Covid, the Centre rose to the challenge of providing outreach services to the frail, elderly and under privileged in the community through their directors, staff and a team of volunteers. Services included

- Preparing and delivering cooked meals
- Delivering Medical Prescriptions from Dunbeath and Lybster medical Centres
- Delivering Newspapers
- Grocery shopping and delivery
- Delivering bulk supplies of hand sanitiser to locations throughout Caithness
- Transporting folk to the Medical Centre for Covid inoculation
- Transporting people for Local GP and Hospital appointments
- Check in and Chat (telephone calls to vulnerable persons in community)

- Setting up a "Sharing Shack" This shack was stocked up with food and other essentials
 received from Wick Food Bank and C-Fine Aberdeen for use by those who were experiencing
 financial difficulties during Lockdown
- D&DC also obtained and handed out to under privileged families and children 25 Apple Ipads to mitigate isolation and ensure children were not disadvantaged with school work

I apologise to all for the length of this communication but I strongly feel that it is right for the decision makers in the Asset Transfer process to fully understand the work that is carried out by D&DC to benefit the citizens of South East Caithness and it is my sincere hope that they will support their application

I hope that an alternative site or solution can be found which will have a less damaging effect on the lives of the people who actually live in the vicinity.

I write in support of the transfer of ownership of land, south west of Neil Gunn Road, to Dunbeath & District Centre.

I moved back to Dunbeath, from Aberdeen, to retire and enjoy country living in my home village. A large part of the enjoyment of living here is the community spirit and the willingness to help one another.

The Dunbeath & District Centre has become a large part of my life since lockdown. I now appreciate all that they do and how much they contribute to the village and the larger community out with Dunbeath. I have been volunteering at the Centre since the beginning of Lockdown. I alongside other volunteers, have delivered meals to the elderly and vulnerable regularly since then. The need for meals to be delivered was in high demand from the start of Lockdown. We not only delivered meals, we also delivered prescriptions and shopping to those who could not leave their houses in the Pandemic. Not only was this a delivery service it was a 'keep in touch' service too. We checked up on people and made sure they had what they needed. It was harder in the winter when visitors were not allowed, families of the elderly and vulnerable were reassured that their loved ones were being checked on at regular intervals.

I also took the people without transport, or who had disabilities, to their Covid vaccinations. This was only doable because of Dunbeath Centre. There is a Caithness Rural Transport bus available to the Centre and this was used as transport. This was achievable because there was a donation given to the Centre to pay for the use of the bus.

I fully support the request for the transfer of the land, mentioned in the first sentence, to be put in to the name of Dunbeath & District Centre. There is a growing requirement for help, for the elderly and vulnerable in the area, that can only be met with the expansion of the services provided by the Centre.

Re: Notice of Asset Transfer Request Dunbeath & District Centre

Dear Mr McIntosh

I was somewhat surprised recently when I saw the NOTICE OF ASSET TRANSFER REQUEST just a few weeks ago. Despite being in the community every day I was completely unaware that such an elaborate plan and building were being considered in the vicinity. Following seeing the notice I found the business plan for the proposed development and read it to find out what was going on. I base my objections on the following.

- In the plan it refers to a survey based on a questionnaire which 'used online and offline' methods. My question is how were the public supposed to know where this questionnaire was available? It certainly did not seem to be circulated widely as these things should be. I believe there may have been some in the medical centre which, given the premises had restricted access would not be available to many people. It is easy to get a survey to show the desired results if it is targeted selectively rather than circulated generally.
- The secrecy that has shrouded this proposal leaves me somewhat disturbed. Particularly as I have since learned that a new employee has been appointed as an Operation Growth Manager which would indicate that the NOTICE OF ASSET TRANSFER REQUEST may be just a paper exercise. Surely not a fait accompli? In the advert for this post it states the candidate will 'support the board, staff and volunteers to make the community's dream a reality'. Whose dream? What community? This seems a sweeping claim when many people in the community were not even aware these plans were afoot.
- Many of the claims in all the documentation and spin would give the impression that the current centre is bursting at the seams and a hive of activity. In reality this is not the case

 it is very seldom open in the evenings unless there is a special function (currently on Tuesday's there is an evening meal open to all). The same can be said for the weekends when it has mainly been completely unused. Who caters for the needy and isolated then?
 I can understand that there may be a requirement to extend the catering space in the centre as it stands but does this justify a massive investment in a new building and all the associated upkeep costs. Given the site in question, the groundworks alone will be a major expense.

- If I remember correctly some time ago the local community council made a request to the
 Dunbeath Centre (or whatever its moniker was at that time) to look at acquiring the
 ground to increase the sheltered housing that is already there which has been very
 successful. As far as I am aware this was not progressed by the centre and yet in my
 opinion would be much more suited to the area of ground under consideration. The
 minutes of the community council could probably corroborate this.
- The business plan seems to suggest that the social activities they mention could not be held except with larger premises at the 'centre'. The villages of Latheron, Berriedale and Dunbeath have well-appointed community halls which seem to have been largely ignored. Our local medical centre has rooms for physiotherapists and chiropodists – the space to offer these services does not seem to be the problem but rather a shortage of qualified personnel – this problem will not be overcome by extra space.
- In conclusion I believe the proposed development is completely excessive and out of place in the space available. Alas the sketch in the business plan did not give a good representation of the footprint and was not much help.

Given that this has all been such a secretive and covert plan that many people in the locality had no idea about, I would suggest that a survey be carried out by an independent agency to truly assess the views of those for whom the centre is targeted – myself being one of them. It is easy to increase usage and swell numbers in the short term when some very attractive subsidised activities and services are offered.

Representation 19

I write regarding the request for ownership of the land south-west of Neil Gunn Road, Dunbeath from Dunbeath and District Centre for the site of a new Health and Well Being Centre and wish to oppose the transfer.

There is little support for the project in the community and the feeling is that the current management have strayed from the original purpose of the Centre, which has been an asset to the community for many years and is still more than adequate for community needs. There is also concern that approximately £40,000 has been spent refurbishing the Centre recently which will have been a total waste of money.

A major concern in the public is that a survey which was conducted on behalf of the Centre, very few local residents knew about and the only place where survey forms were available was in the local medical centre and this at a time where attendance at the medical centre was limited due the Covid epidemic! It is therefore evident that the majority of the returned survey forms were completed by day centre users, many of whom live outside the village. It would seem that the survey mainly reflected the views of the Centre users thus giving the result the management desired.

Apart from the foregoing reasons, I consider that the location of the proposed Centre is entirely unsuitable given the terrain of the site and the limited parking space available as the area is already congested. The height and size of the proposed building is completely out of character with the surrounding housing and will stick out like the proverbial "sore thumb" in that location, further much needed sheltered housing would be a better use of the site.

It is obvious from representations already published on your site that the management of the Centre have been canvassing neighbouring and local organisations for their support.

In conclusion I feel the whole project has been a covert operation, deliberately keeping the local population in ignorance of their plan.

Dunbeath & District Wellbeing Hub

I fully support the proposal for a new Wellbeing Hub at Achorn Road, Dunbeath. The current centre is a strong community hub and an invaluable resource, acting as an emergency centre when called on and providing community resilience during the covid pandemic.

It provides freshly cooked meals - in-house, take-away and delivered daily to the wider community, It also offers a delivery service for groceries, medications, games, books etc. The centre has a wide range of activities and services including yoga, pilates, arts & crafts, walking groups, hairdresser and much more, all of which help to support positive physical and mental health in a rural area which lacks amenities.

The centre is also an important employer in the area with 1 full-time and 3 part time positions.

I wish to object to this proposed large expansion of the DDC. I was aware of this only very recently, purely by chance, during the second week of November.

I believe that the asset transfer should not go ahead until there is a full survey of the whole community, not just the 'users' and selected organisations who are likely to give their support. This should have been done at the outset, during August. A new survey should be undertaken by a totally independent group/organisation and the results made public.

I understand that the demographic of the questionnaire is not available. DDC's business plan has some debatable statements such as '...to make the community's dream a reality ...' since the whole community hasn't been consulted.

For transparency, a full breakdown of the figures of the individual activities should be provided, rather than just the overall totals of those attending the DDC. It also states that the DDC works with local businesses but by providing ever more meals at cheap and subsidised prices this will inevitably impact upon them.

I am writing to object about the proposed asset transfer of land to the Dunbeath & District Centre.

There are several reasons for this:-

- 1. Proposed location is wholly unsuitable for such a development. The elevated position is far too imposing over the sheltered housing below and I would expect significant groundworks to support such a structure, again with a detrimental effect to the neighbouring housing.
- The present road set up, with the bus stop turning area around the war memorial coupled with proximity to the doctors and Post office is confusing and dangerous enough with the present traffic volume. The additional traffic coupled with elderly pedestrians and school children is a recipe for disaster.
- 3. The Dunbeath & District Centers purpose has changed considerably from the initial concept. While this in inevitable and change in general is a good thing, it has now gotten to the point that it's starting to impact other organisations in the area. i.e. Local cafes, eateries, Community Centre. These resources already exist and have to stand on their own, it is neither fair or right that they should face competition from a heavily subsidised charity.

In short, even if there was a requirement for such a facility over and above what already exists, which the majority of locals seem to disagree with, this would not be the location for it.

Re: Land SW of 9 Neil Gunn Road, Dunbeath - Dunbeath & District Centre

The prime reason for the request for the land use is for the construction of an improved Health and Well Being centre for Dunbeath and the surrounding area.

However, in the application there is also mention of residential plots and a change in use of the current centre for future residential use or as respite accommodation.

In the documentation provided there are illustrations of the centre but not of the planned residential use. Indeed, I noted that while the priority is for the construction of a new centre, the preferred option is to have 2-4 residential units in addition. There is no detail on this and this needs to be clarified.

There is clearly support from users of the current centre who rightly highlight the hard work, dedication and support given by the centre staff, and other important parts of the community have also voiced support for a new centre. All that said, I remain disappointed that I, as a resident of Dunbeath, do not appear to have been given an opportunity to voice support or concerns nor to ask questions of the proposal. The questions that are not meant to be negative, but are there to clarify in detail what is being proposed.

In the representation by the chairman of the Berridale and Dunbeath Community Council, I agree that there appears to have been little communication of this submission to the wider local community and that is a concern. My property is around 50m from this proposal, but I did not receive any information nor was I invited to any representation on this matter. For example, why was there no Public Notice placed in the the nearby Post Office. This application/proposal therefore may not completely meet the guidance of requirements

given within the **Community Empowerment (Scotland) Act 2015: asset transfer,** paragraphs 8.27, 8.28 and 8.29.

Finally ,what Evironmental Impact Assessment has been carried out? This will be a building project near to current sheltered housing. What mitigations will be need to be put in place by the contractor(s)?
