## Hi David

Just a wee note of support for the proposal that the Leisure Centre group be granted the use of the former playgroup building as a fitness and gym facility for the whole community. I feel this is a very fitting use for a unit which was purchased with so much hard work, sweat and tears and the deep pockets of our community in the first place.

Many years ago Lochcarron playgroup was extremely grateful to Howard Doris for the use of a finlog house for our local playgroup which had been meeting in the village hall for some time, which meant getting out equipment and salting it away again every session.

However, we knew that our time in the finlog house was numbered, as the houses would be sold when Howard Doris closed the Kishorn site, so we were once again looking for premises suitable for a playgroup.

I was by this time playleader, taking over when our local dentist and his wife Donna who had been playleader, left the area.

Together, the parents using the group, the committee from amongst them, and myself as playleader, began to fund raise in earnest to raise money that we could then use to match grants available in order to purchase a portacabin. I am sure many in the community will remember our fantastic sales and Christmas Fayre's with our Santa's grottos. I recall all too well my own tears on the cabin's arrival in Lochcarron as I was not going to be the playleader in it, having just accepted a post with the Playgroup Association. But the job entailed visiting and supporting lots of community playgroups and the contrast between having a designated unit to using a community hall was so marked.

It was a huge community fundraising effort though, and of course later, the unit was even more important, when nursery education came in. It allowed our three and four year olds to enjoy their preschool education in the unit. But the demands on the parent managers and staff became too much, as times move on, often both parents work and the demands on community run preschool nurseries has become untenable, because nursery education in non-local authority primary school nursery classes, is still subject to full HMI inspections etc. Sadly the parents and staff agreed they should hand over to the Education Authority and this year the unit became vacant.

As I understand it, the Leisure Centre group's bid to repurpose the unit into a fitness room and gym for the community can happen via the Community Asset Transfer process. It seems a fitting use for a unit initially bought by the efforts of the whole community. Many of the children who attended the playgroup are now young adults and particularly keen on exercise and fitness. There are younger families coming into the village all the time, who are perhaps used to having such a facility available to them. Finally I believe that all ages are particularly concerned about our health and well being after these strange times.
