

**THE HIGHLAND COUNCIL (DRAKIES, INVERNESS) (20MPH SPEED LIMIT)  
ORDER 2021**

The Highland Council in exercise of the powers conferred on them by Section 84 of the Road Traffic Regulation Act 1984 and of all other powers enabling them in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act hereby make the following Order:-

1. This Order may be cited as "The Highland Council (Drakies, Inverness) (20mph Speed Limit) Order 2021" and shall come into effect on 19<sup>th</sup> February 2022.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. All provisions contained in any Order enactment or others insofar as the same are inconsistent with the provisions of this Order and the true intent and meaning hereof shall cease to have effect and are hereby revoked.

In particular, the provisions of the The Highland Council (Drakies Primary and Inverness Royal Academy, Inverness) (Part Time 20mph Speed Limit) Order 2006 are revoked in so far as they relate to the lengths of road specified in the Schedule hereto.

**ROADS (20MPH)**

4. No person shall drive or cause or permit to be driven any vehicle on the lengths of road specified in the Schedule annexed and signed as relative to this Order at a speed in excess of 20 miles per hour.


