THE HIGHLAND COUNCIL PROPOSE TO CONSTRUCT 2 SETS OF SPEED CUSHIONS ON A949 EVELIX ROAD AND ONE ROAD NARROWING AND UNCONTROLLED PEDESTRIAN CROSSING POINT ON U3357 SUTHERLAND ROAD, DORNOCH

NOTICE IS HEREBY GIVEN that **The Highland Council**, in terms of the powers contained in section 36, 37 AND 39A of the **Roads (Scotland) Act 1984** as amended, The Road Humps (Scotland) Regulations 1998, and of all other powers enabling them in that behalf proposes to construct 2 sets of speed cushions on A949 Evelix Road and 1 road narrowing and uncontrolled pedestrian crossing point on the U3357 Sutherland Road Dornoch as follows:

Description of the proposed speed cushions:-

- First pair of speed cushions is 103 metres or thereby Northwest of B9168 Poles Road, A949 Evelix Road, Dornoch
- Second pair of speed cushions is 111 metres or thereby Southeast of B9168 Poles Road, A949 Evelix Road, Dornoch

The speed cushions are 75mm in height (max), 1600 mm wide and 1900 mm in length with approach ramp gradient of 1:8 and slope gradient of 1:4.

Description of the proposed road narrowing and uncontrolled pedestrian crossing point:-

• 79 metres or thereby Northeast of the U5614 Mackay Road, U3357 Sutherland Road, Dornoch.

The road narrowing is on both sides at the same position along the carriageway by constructing build out flushed to the footpath at the West side and build out on the East side flushed to the footpath. Build outs on both side of the carriageway shall be of equal width reducing the carriageway width to 3.5m kerb to kerb. The build outs shall have an upstand to match existing kerb levels and is 6.1m in length. Road signs and road markings will be installed as per the Traffic Signs Regulations and General Directions 2016. Priority shall be given to vehicles travelling South-westerly.

In terms of Section 7 and Schedule 6 Part 3 paragraph 9 of the Coronavirus (Scotland) Act 2020, the Council has decided not to make the schedule and plans available for public inspection or publicise them other than by electronic means because to do otherwise may give rise to a significant risk of the transmission of coronavirus.
