

**THE HIGHLAND COUNCIL**  
**PROPOSE TO CONSTRUCT A SERIES OF TRAFFIC CALMING ON THE A862, BEAULY**

NOTICE IS HEREBY GIVEN that **The Highland Council**, in terms of the powers contained in section 36, 37 AND 39A of the **Roads (Scotland) Act 1984** as amended, The Road Humps (Scotland) Regulations 1998, and of all other powers enabling them in that behalf proposes to construct 2 raised table humped crossings and 2 sets of speed cushions on the A862 Station Road and High Street as follows:

Description of the proposed raised table, humped crossing on Station Road near Phipps Hall -

- Raised table, humped pedestrian crossing located on the A862 Station Road. The raised table starts 131 m northeast of the junction with Station Road and Braeview Park at the locations of the existing lights-controlled crossing. This raised table will be 75mm in height (max) across the carriageway kerb to kerb (6.9 m wide). This consists of a raised section (75 mm in height) 2700 mm in length with two tapered ramps located on each side 1125mm wide.

Description of the proposed raised table on High Street -

- Raised table uncontrolled pedestrian crossing located on the A862 High Street. The raised table starts 35 m northeast of the junction with A862 High Street and Croyard Road. This raised table will be 75mm in height (max) across the carriageway kerb to kerb (8.1 m wide). This consists of a raised section (75 mm in height) 3600 mm in length with two tapered ramps located on each side 1100 mm wide.

Description of the proposed speed cushions: -

- First pair of speed cushions is 17 m Northeast of the junction of the A862 and Orchard Park, Beauly
- Second pair of speed cushions is 90 m Northeast of the junction of the A862 and Orchard Park, Beauly

The speed cushions are 75 mm in height (max), 1600 mm wide and 1900 mm in length.
