

**THE HIGHLAND COUNCIL (VARIOUS ROADS, TAIN) (20 MPH AND 30 MPH SPEED LIMIT)
ORDER 2022**

NOTICE IS HEREBY GIVEN that The Highland Council proposes to make an Order in terms of Section 84 of the Road Traffic Regulation Act 1984 entitled as above.

If the Order comes into force, the Order will introduce a 30 mph speed limit on the following road in Tain as stated below:

B9174 – Tain Streets, (i) from a point 65 metres or thereby north-west of its junction with Well Street to a point 12 metres or thereby east of its junctions with the A9 Trunk Road for a total distance of 660 metres or thereby. (ii) from a point 55 metres or thereby south-east of its junction with Knockbreck road to a point 35 metres or there by north-east of its junction with the A9 Trunk Road for a total distance of 475 metres or thereby.

The Order will also introduce a 20 mph speed limit on the following roads in Tain for their entire length, unless stated otherwise below:
