PROPOSE TO CONSTRUCT A RAISED JUNCTION AT THE B970 STATION ROAD / C1141 SPEY STREET JUNCTION, AND A RAISED TABLE UNCONTROLLED PEDESTRIAN CROSSING ON THE B970 STATION ROAD, KINGUSSIE

NOTICE IS HEREBY GIVEN that **The Highland Council**, in terms of the powers contained in section 36 AND 37 of the **Roads (Scotland) Act 1984** as amended, The Road Humps (Scotland) Regulations 1998, and of all other powers enabling them in that behalf proposes to construct a raised junction and raised table uncontrolled pedestrian crossing point on the B970, Station Road, Kingussie.

Description of the proposed raised junction-

- Station Road, the north ramp is 13 metres or thereby North of the centre line of the C1141 Spey Street, B970 Station Road Junction, Kingussie.
- Station Road, the south ramp is 36 metres or thereby South of the centre line of the C1141 Spey Street, B970 Station Road Junction, Kingussie.
- Spey Street, the east ramp is 15 metres or thereby east of the centre line of the C1141 Spey Street, B970 Station Road Junction, Kingussie.
- Train Station Access Road, the west ramp is 11 metres or thereby west of the centre line if its junction with the B970 Station Road, Kingussie.

The ramps are 75 mm in height (max), full road width and 1125 mm in length with approach ramp gradient of 1:15.

The raised junction created will be 49 metres long on Station Road, it extends 15 metres along Spey Street and 11 metres along the Train Station access road.

Descriptions of the proposed Raised Table Uncontrolled Pedestrian Crossing on B970 Station Road, Kingussie.

- 58 metres north of the junction of the C1141 Spey Street, B970 Station Road Junction

The raised table uncontrolled crossing point is a raised table 75mm in height (max) across the carriageway from kerb to kerb. This consists of a raised section (75mm in height) 3000 mm wide on top with two tapered ramps located on each side 1125 mm in width.
