THE HIGHLAND COUNCIL (AVIEMORE) (20 MPH SPEED LIMIT) ORDER 2022

The Highland Council in exercise of the powers conferred on them by Section 84 of the Road Traffic Regulation Act 1984 and of all other powers enabling them in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act hereby make the following Order: -

- 1. This Order may be cited as "The Highland Council (Aviemore) (20 mph Speed Limit) Order 2022" and shall come into effect on 21 December 2022.
- 2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. All provisions contained in any Order enactment or others insofar as the same are inconsistent with the provisions of this Order and the true intent and meaning hereof shall cease to have effect and are hereby revoked.

In particular, the provisions of The Highland Council (Coronavirus) (Aviemore) (Temporary 20mph Speed Limit) Order 2020 are revoked in full and the provisions of The Highland Council (B9152 Aviemore) (30 mph Speed Limit) Order 2007 are revoked in so far as they relate to lengths of road specified in the Schedule annexed and signed as relative to this Order (hereinafter referred to as "the Schedule").

ROADS (20MPH)

4. No person shall drive or cause to be driven any vehicle on the lengths of road specified in the Schedule at a speed in excess of 20 miles per hour.
