**THE HIGHLAND COUNCIL (C1019 OLD CAITHNESS ROAD),
HELMSDALE (ONE WAY), TRAFFIC REGULATION ORDER 2022**

The Highland Council in exercise of their powers under Sections 1(1) and (2), 2(1) to 2(3), 3, and 4(1) to 4(3) of the Road Traffic Regulation Act 1984 as amended (which Act as so amended is hereinafter referred to as “the 1984 Act”), and of all the other enabling powers and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following order:-

1. This Order may be cited as “The Highland Council (Old Caithness Road), Helmsdale (One Way), Traffic Regulation Order 2022” and shall come into operation on **DATE**.
2. The Interpretation Act 1978 shall apply for the interpretation of this order and of all other orders revoked by this order as it applies for the Interpretation of an Act of Parliament.
3. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made under the 1984 Act or by or under any other enactment.
4. All provisions contained in any Order, Enactments or Others in so far as the same repeat or are inconsistent with the provisions of this Order and true intent and meaning hereof shall cease to have effect and are hereby revoked
5. No person shall drive or cause or permit any vehicle to be driven on the lengths of road specified in Column 1 of the Schedule hereto other than in the direction specified opposite in Column 2 of the said Schedule.

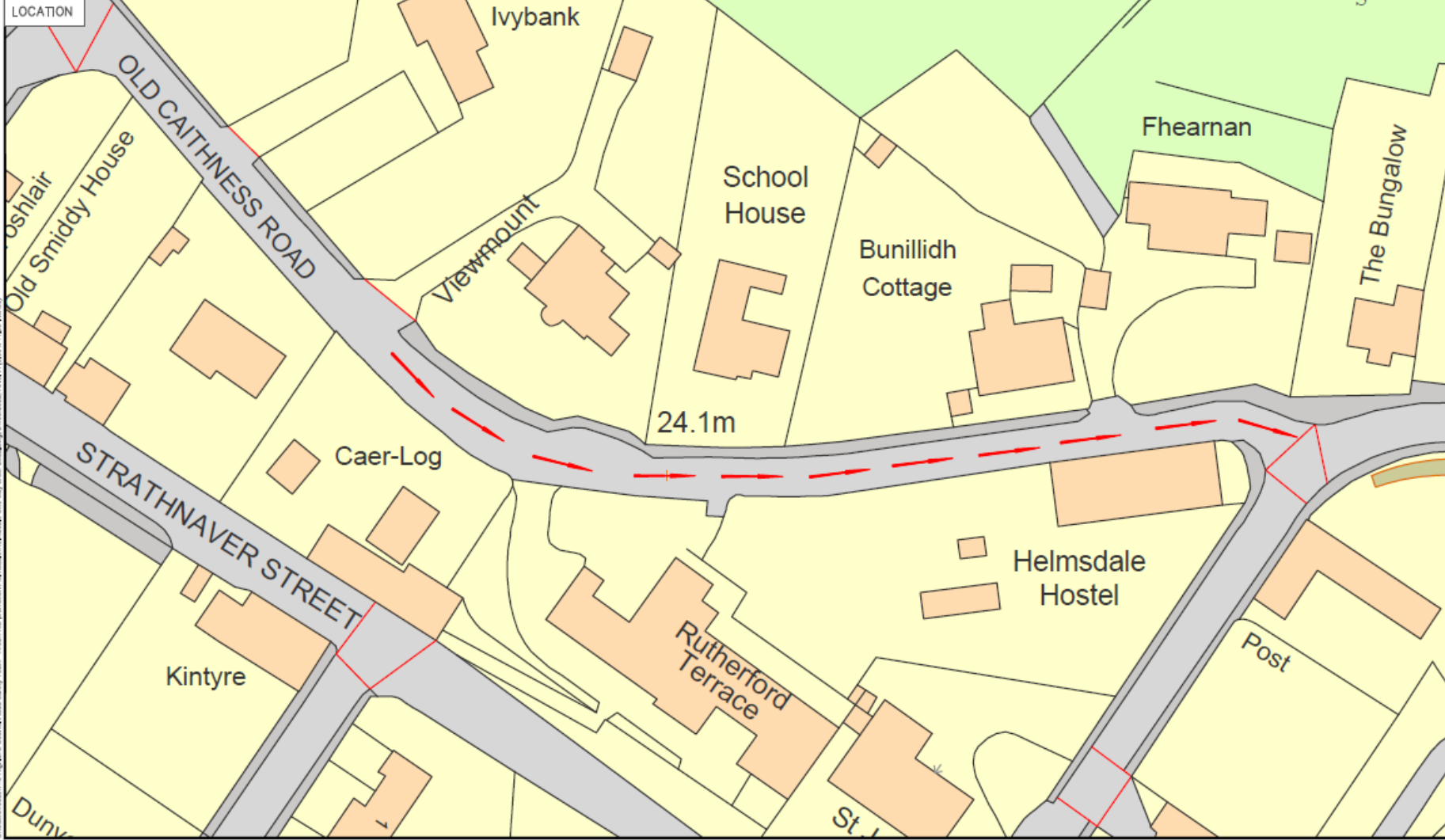
LOCATION
