Notice of Election

NOTICE IS HEREBY GIVEN that elections to elect one Member to the Cairngorms National Park Authority Board to represent each of the FIVE (5) wards within the National Park Area will be held on Thursday 23 March 2023, in accordance with the Cairngorms National Park Elections (Scotland) Order 2003.

Prospective candidates can request a nomination paper from the office within the ward they wish to stand (contact details in Schedule 1). Further information is available from any of the offices detailed in schedule 1 and Nomination forms are also available to download at www.highland.gov.uk/elections.

To qualify, candidates must be:

- 21 years of age or over,
- but need not be resident in the Ward for which they wish to stand, nor the Park area generally.

The candidate's nomination paper must be subscribed to by 2 electors as proposer and seconder and by 4 other electors living in that electoral ward as assenting to the nomination.

All nomination forms must be duly completed and returned by hand to the appropriate ward Depute Returning Officer, by appointment, **no later than 4pm on Wednesday 15 February 2023.**

Before the original documents are delivered to the appropriate Depute Returning Officer's office, candidates may scan and email their forms electronically to the appropriate office email address in schedule 1 for an informal check.

In the event of a poll, ballot papers will be issued to all eligible electors on Tuesday 28 February 2023. Completed postal votes must be returned by 2pm on Thursday 23 March 2023 to be included in the counting of votes.

All eligible electors have already been advised by post of the electoral ward they will be entitled to vote in. Anyone who has not received notification, and who wishes to clarify their entitlement to vote should contact the appropriate Electoral Registration Officer as detailed in Schedule 2 below. Any elector can apply to the Electoral Registration Officer to have their ballot paper sent to an address other than that appearing on the electoral register. To do this they need to apply to the appropriate office (contact details in Schedule 2) below no later than 5pm on Thursday 16 February 2023.

Guidance for Completion of Nomination Forms



Please read these notes carefully before completing the nomination form

(1) Candidates

It is the responsibility of the Candidate to ensure that the nomination form is properly completed and duly submitted. If papers are returned in good time, errors may be identified, and an opportunity given to amend the paper. If there is insufficient time for this prior to the close of nominations (Wednesday 15 February 2023 at 4pm), a nomination paper may be ruled invalid.

Candidates must be aged 21 at the time of their nomination and must sign the consent to nomination and the other statutory declarations contained in the nomination form. **Candidates do not need to be resident in the Ward for which they wish to stand, nor the Park area generally.**

Candidates should give their full legal name where required on the form. However, if Candidates wish to be described on the ballot paper by a name that is different from this, they must detail this on the nomination form. For example, James Brown is known to all his friends as 'John'. On the nomination form he should enter John against 'commonly used forename (if any)' John Brown will therefore be the name that will appear on the Statement of Persons Nominated and the ballot paper instead of James Brown.

(2) Proposer, Seconder and Assentors

The nomination form requires to be subscribed by **2** electors as proposer and seconder and **4** other electors as assentors who are eligible to vote in the National Park ward in which the Candidate is standing.

Any names and addresses given must be as they appear in the Register of Electors. Electoral Numbers can be obtained or checked by contacting the appropriate Electoral Registration Office listed below.

Candidates must **print** in full their name and address, as well as the names and addresses of their proposer, seconder and assentors.

A person shall not subscribe more than one nomination form for the same ward and must be at least 16 years of age on the day the nomination paper is signed.

If a proposer, seconder or assentor does subscribe more than one nomination paper, and this is not corrected by the close of nominations, the first nomination paper received with that individuals signature will remain (in that respect), valid, and any subsequently subscribed nomination papers will be deemed invalid.

(3) Informal Check of Nomination Form

Whilst nomination packs must be submitted to the appropriate office listed below, the Returning Officer is offering an informal checking service, provided the nomination forms are submitted sufficiently far in advance of the close of nominations.

Candidates should be aware that the nomination forms are being checked informally and the Returning Officer or his staff cannot be held responsible if they fail to identify any error or omission during the informal check. The completion of the nomination form remains the responsibility of the Candidate.

Informal papers for checking should be submitted by email to the appropriate Depute Returning Officer listed at annex 1 with the candidate's contact telephone number and they will be acknowledged with a receipt of their request. After the informal check has been completed, the Candidate will be contacted to advise them of any errors identified to be corrected before the final submission. If there have been no issues identified the Candidate will be invited to make an appointment and formally submit the form by hand to the Depute Returning Officers at the appropriate office listed at annex 1.

Once a nomination form has been validated, the Candidate cannot make any further changes.

(4) Submission of Final Nomination Form

Final nomination forms must be the original with wet signatures and delivered by hand to the appropriate Depute Returning Officer listed at annex 1. It is recommended that you contact the appropriate Officer in advance to arrange an appointment. The receipting of completed nomination form is between the hours of 10am and 4pm Monday to Friday from the day after publication of the Notice of Election (Thursday 19 February 2023) until the close of nominations at 4pm on Wednesday 15 February 2023.

The Returning Officer will not accept any nomination forms delivered after 4pm on Wednesday 15 February 2023.

(5) Withdrawal of Nominations

Withdrawal of nominations will only be valid if a duly completed and returned withdrawal of nomination form is submitted to the appropriate Depute Returning Officer (as detailed in annex 1) by 4pm on Wednesday 15 February 2023.

Where a Candidate has submitted nomination forms in respect of more than one ward, they must give notice on the enclosed withdrawal form that they are withdrawing from all but one ward, or they shall be deemed to have withdrawn as a Candidate in all of those wards.

(6) Candidate's Statement

Candidates may submit a statement either on the form enclosed or in any other form. The statement must be submitted within the time for delivery of Nomination Papers before 4pm on Wednesday 15 February 2023. The statement must not be more than 250 words long. If the statement exceeds 250 words, Candidates will be invited to reduce the length of the statement. If the Candidate does not reduce the length of the statement, the Returning Officer will publish the first 250 words thereof.

The statement must clearly have printed the name of the candidate and ward number. A copy of your candidate's statement must also be hand delivered with your nomination paper. In order for us to publish your statement, Candidates are being encouraged to submit their statement electronically by email in word format or PDF to the appropriate Depute Returning Officer detailed in annex 1.

In accordance with the election order, copies of statements will be sent with the ballot paper, to every elector within the relevant ward. If a candidate does not submit a statement within the deadline then electors will be informed on the list of statements that no statement was received.

By virtue of paragraph 11 (4) of Part II of The Cairngorms National Park Elections (Scotland) Order 2003, the Returning Officer retains the right to refuse to issue such communications if, in his opinion, the contents of the communication are unlawful.

(7) Election Expenses

No sum shall be paid and no expense shall be incurred by a candidate at this election, whether before, during or after the election, on account of or in respect of the conduct or management of the election in excess of £250.

All Candidates will be required to complete a Declaration of Election Expenses Form containing a statement of all payments made by that candidate together with all bills and receipts. Please note that such sums incurred by the candidate are not refundable. The expense forms will be issued to candidates after the close of nominations.

The completed Election Expenses Forms require to be returned to the Returning Officer by Thursday 27 April 2023. Forms must be returned even if no expenses (NIL) have been incurred.

Disqualifications for nomination, election and holding office as a Member

7. (1) Subject to paragraphs (2) and (3) below, a person shall be disqualified –
- (a) from being nominated as a candidate for election as, or from being elected, or from being, an elected Member if –
 - (i) he or she holds any paid office or employment or other place of profit in the gift or disposal of the Authority;
 - (ii) he or she is a person whose estate has been sequestrated or who has been adjudged bankrupt or has made an arrangement with creditors or has granted a trust deed for creditors or a composition contract;
 - (iii) he or she has, within five years before the day of nomination, or of election or since his or her election, as the case may be, been convicted in the United Kingdom, the Channel Islands, the Isle of Man or the Irish Republic of any offence and has had passed on him or her a sentence of imprisonment (whether suspended or not) for a period of not less than three months without the option of a fine;
 - (iv) he or she is disqualified from being elected under Part III of the Representation of the People Act 1983; or
 - (v) he or she is incapacitated by physical or mental illness from discharging the functions of a Member;
 - (b) from being an elected Member if he or she has been absent from meetings of the Authority for a period longer than three consecutive months without the permission of the Authority.
- (2) Where a person is disqualified under paragraph (1) above by reason of his or her estate having been sequestrated, the disqualification shall cease if and when –
- (a) the sequestration of his or her estate is recalled or reduced; or
 - (b) he or she is discharged under or by virtue of the Bankruptcy (Scotland) Act 1985.
- (3) Where the person is disqualified under paragraph (1) above by reason of having been adjudged bankrupt, then –
- (a) if the bankruptcy is annulled on the ground that he or she ought not to have been adjudged bankrupt or on the ground that his or her debts have been paid in full, the disqualification shall cease on the date of the annulment;
 - (b) if he or she is discharged with a certificate that the bankruptcy was caused by misfortune without any misconduct on his or her part, the disqualification shall cease on the date of his or her discharge; or
 - (c) if he or she is discharged, without such a certificate, his or her disqualification shall cease on the expiration of five years from the date of his or her discharge.
