




The Victorian Market, Inverness

Location & Description:

The Victorian Market is located in the city centre with entrances from Academy Street, Church Street, Union Street and Queensgate to access all retailers. Unit 6 is located in the Market Arcade, which is directly accessible from Academy Street.

The Market has a rich retail history which attracts both our local population and international visitors all year round. The redevelopment of the Food Hall in 2022 has greatly increased footfall within the market.

The unit benefits from ground floor accommodation with fitted cupboards, which extends to 13.88 sq.m, with additional mezzanine storage of 9 sq.m, accessed via a steep staircase.

Lease Terms & Conditions:

The property is offered for let for an initial period of five years on Council's Standard Conditions of Let for the Victorian Market. The lease contains provision for the landlord or tenant to serve notice to quit any time after the first year, on giving three months' written notice.

You will be responsible for meeting all the legal costs of preparing the lease. You will also be liable for any LBTT, Registration Dues and VAT thereon.

Rent, VAT, Property Insurance & Utilities:

You will pay the first quarter's rent and insurance in advance of taking entry and thereafter monthly in advance by Direct Debit.

You will be responsible for choosing your utility suppliers (e.g. electricity and water) on taking entry to the property and paying all charges during your tenancy.

Rateable Value & Annual Business Rate:

The property's Rateable Value is £5,500 and the 2025/26 Annual Business Rate is 49.8p.

If you believe you may be exempt of liability for Non Domestic Rates, it is your responsibility to apply for the appropriate exemption.

Other information:

Opening hours and access to the Victorian Market are Sunday to Thursday 7am – 6pm Friday and Saturday 7am to 8pm.
