Election of Members



- (1) As there is more than one validly nominated candidate in each of the (Four) 4 Wards of the Cairngorms National Park Authority, a poll will take place to fill a vacancy for a Member for each Ward. The name of each candidate, and of the candidate's proposer and seconder, are provided below.
- (2) The poll will be conducted by post and all ballot papers will be issued on Tuesday 28 February 2023. Ballot papers must be returned by post in the pre-paid envelope addressed to the Returning Officer, The Highland Council, Election Office, Glenurquhart Road, Inverness, IV3 5NX no later than 2pm on Thursday 23 March 2023.
- (3) The persons who can vote at this election are those registered and entitled to vote as per the Register of electors for the local authority election in the contested wards of the Cairngorms National Park area.
