# Candidate's Statement by PETER JOHN ARGYLE

I am an outdoors enthusiast and I have spent many hours walking, cycling, orienteering, canoeing, skiing and horse riding in the Park.

I have a Degree in Ecology, a Masters in Water Resource Management and thirty-five years' professional environmental consultancy experience. I am a Chartered Ecologist and I worked at Board level in the Chartered Institute of Ecology and Environmental Management (CIEEM) for seven years (2012-2019). I currently serve on the NatureScot Scientific Advisory Committee (SAC) Expert Panel and I am the Coordinator for the North East Scotland Biodiversity Partnership (NESBiP).

My specialism is freshwater ecology and I have specific experience in river restoration. I have undertaken numerous projects in the Cairngorms National Park including in the River Dee catchment. I am currently Chair of the Tarland Wetlands Group, which aims to develop natural wetlands fitting within the farming system, for the benefit of wildlife, the environment and local people.

The twin crises of climate change and biodiversity loss pose many questions about how we manage our freshwaters and alleviate flooding of our communities. Ballater in particular has suffered from several floods in recent storms. I would bring my knowledge and expertise to the Board to deliver sustainable nature-based solutions so that the landscape of the Park and people's homes and livelihoods are protected for future generations.
