ORDER TO EXEMPT LAND FROM ACCESS RIGHTS

THE HIGHLAND COUNCIL (SNOWMAN RALLY 2023) ORDER 2023

The Highland Council in exercise of the powers conferred on them by Section 11 (1) of the Land Reform (Scotland) Act 2003 ("the Act") hereby make the following Order:-

1. This Order may be cited as "The Highland Council (Snowman Rally 2023) Order 2023", and shall come into operation as follows, unless revoked earlier:
 - a. Boblainy from 0600 to 1800 on Saturday 4th March 2023
 - b. Rogie from 0700 to 1900 on Saturday 4th March 2023
 - c. Glenurquhart from 0900 to 1700 on Saturday 4th March 2023
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The effect of the Order is to exempt land, namely the three areas of Forestry & Land Scotland land at Boblainy, Rogie and Glenurquhart forests which are to be used for car rally special stages on the Snowman Rally, each area being shown delineated in red on the plans, numbered 1 to 3, annexed and signed as relative to this Order, from the access rights which would otherwise be exercisable in respect of that land by virtue of Part 1 of the Act. Rights of way are not affected by this Order.

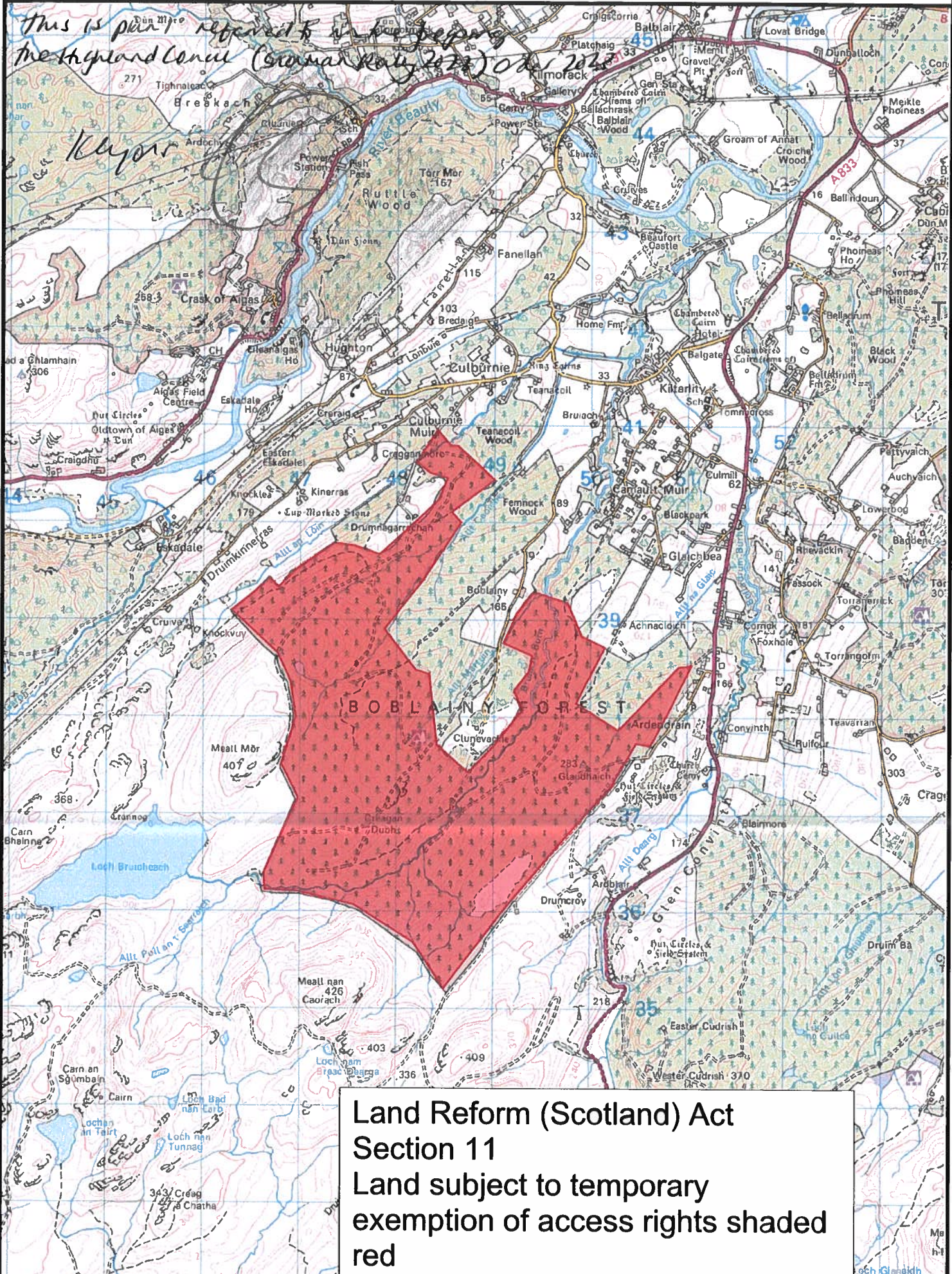

STATEMENT OF REASONS

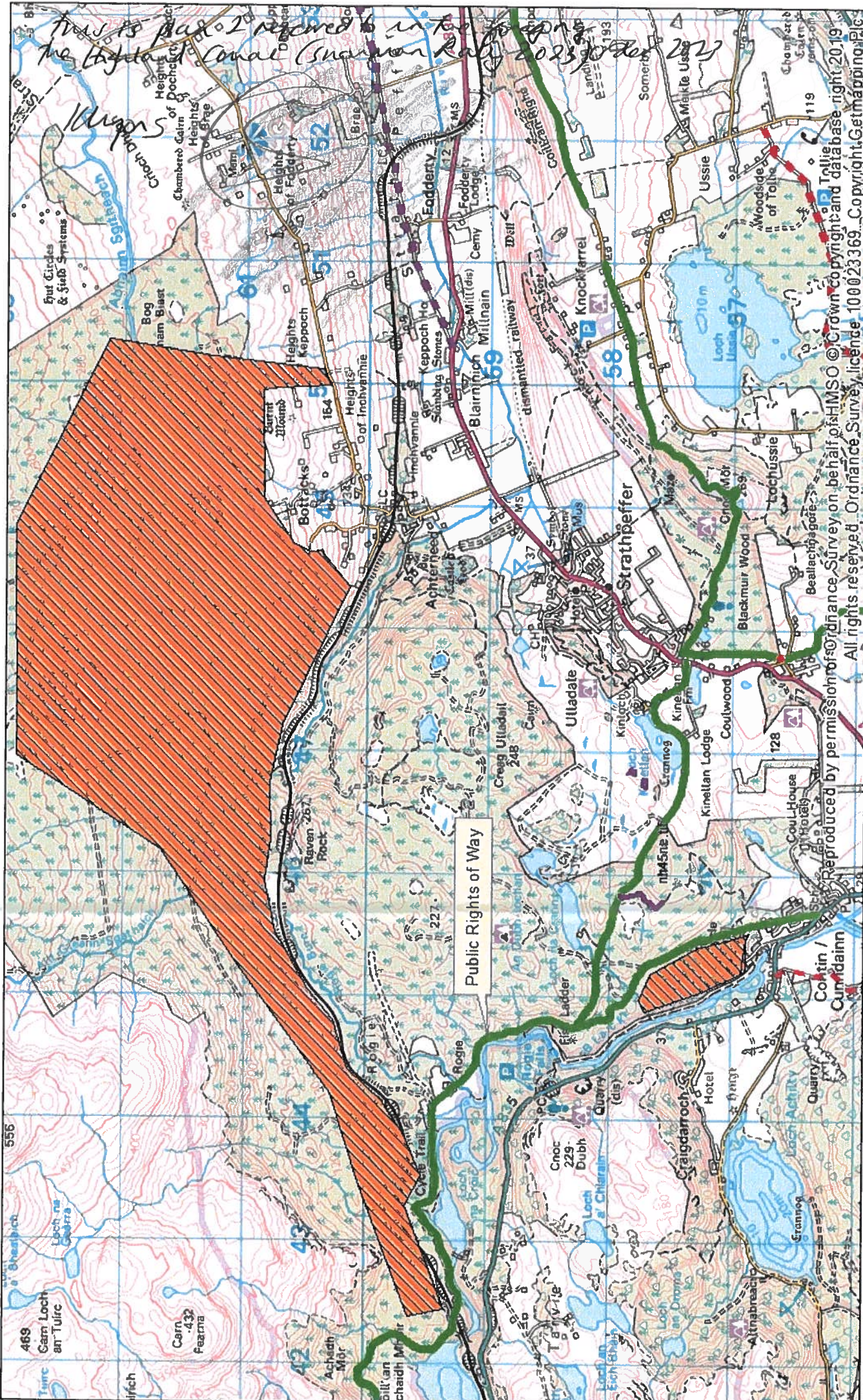
It is considered appropriate to exempt the land stated in the above proposed Order as the Snowman Rally is a high speed, competitive, special stage rally for cars. There will be up to 120 competing cars passing through the three forest sections at one minute intervals. They are competing against the clock and are timed to the second. The Order has been applied for in the interests of safety and security, both for the general public and for the competing crews.

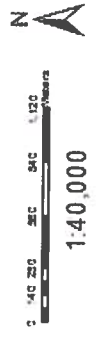

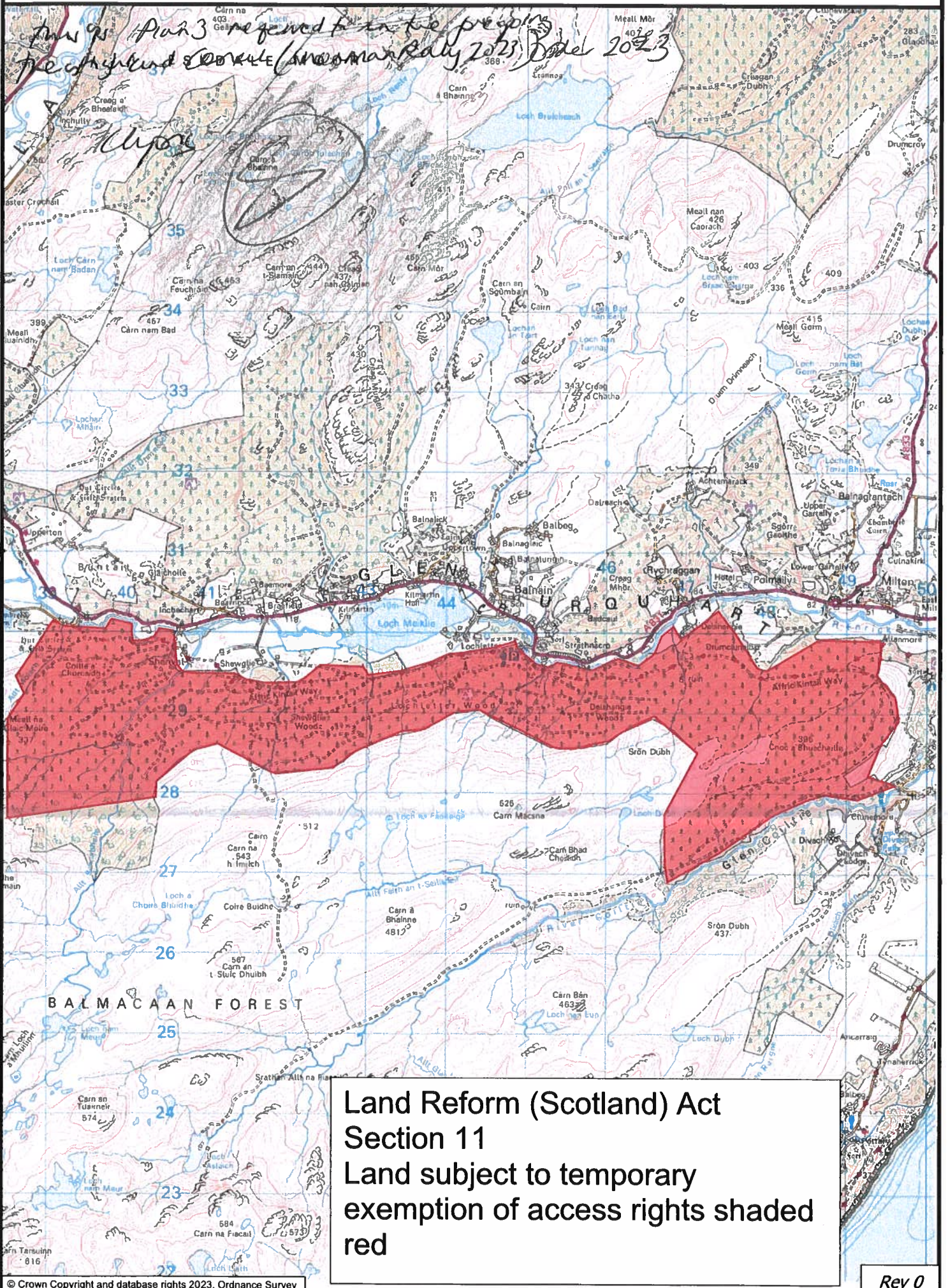
Contin Forest - Snowman Rally
