

**THE HIGHLAND COUNCIL (GRANTOWN ON SPEY) (20MPH SPEED LIMIT)
ORDER 2022**

The Highland Council in exercise of the powers conferred on them by Section 84 of the Road Traffic Regulation Act 1984 and of all other powers enabling them in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act hereby make the following Order:-

1. This Order may be cited as "The Highland Council (Grantown on Spey) (20mph Speed Limit) Order 2022" and shall come into effect at 00:01 hrs on 13 March 2023.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. All provisions contained in any Order enactment or others insofar as the same are inconsistent with the provisions of this Order and the true intent and meaning hereof shall cease to have effect and are hereby revoked.

In particular, The Highland Council (Grantown Grammar School) (Part Time 20 mph Speed Limit) Order 2007 is revoked in full and the provisions of the following orders are revoked insofar as they relate to lengths of road specified in the Schedule annexed and signed as relative hereto: The Highland Council (Grantown on Spey and Kingussie Schools) (Part Time 20 mph Speed Limit) Order 2005 and The Highland Council (Grantown on Spey) (30 mph Speed Limit) Order 2007.

ROADS (20MPH)

4. No person shall drive or cause to be driven any vehicle on the lengths of road specified in the Schedule annexed and signed as relative to this Order at a speed in excess of 20 miles per hour.

This Order together with the 3-page Schedule are sealed with the Common Seal of The Highland Council and signed for them and on their behalf at Dingwall on 3 March 2023 by Shona Ann Pottinger, Solicitor and Proper Officer.

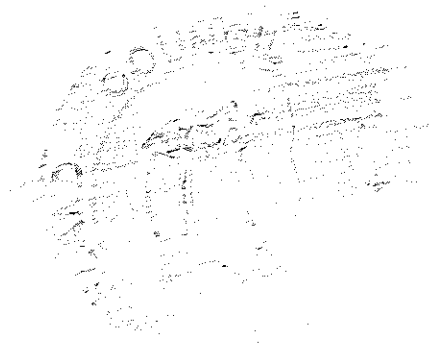
