THE HIGHLAND COUNCIL (GRANTOWN GRAMMAR SCHOOL) (PART TIME 20MPH SPEED LIMIT) ORDER 2007

The Highland Council in exercise of the powers conferred on them by Section 84 of the Road Traffic Regulation Act 1984 and of all powers enabling them in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act hereby make the following order:-

GENERAL

- 1. This Order may be cited as "The Highland Council (Grantown Grammar School) (Part Time 20mph Speed Limit) Order 2007" and shall come into effect on 15 May, 2008.
- 2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. All provisions contained in any Order enactment or others insofar as the same are inconsistent with the provisions of this Order and the true intent and meaning hereof shall cease to have effect during the period of operation of the speed limit hereunder, in particular The Highland Council (Grantown on Spey) (30 mph Speed Limit) Order 2007 shall cease to have effect over the lengths of road specified in the Schedule hereto during such period of operation but shall otherwise remain in effect.

ROADS (20 MPH)

- 4. No person shall drive or cause to be driven any vehicle on the lengths of road specified in the Schedule, and plan number 1, annexed and signed as relative to this Order at a speed in excess of 20 miles per hour at a time when the amber lights on any traffic sign or signs warning of this restriction are flashing.
- 5. It shall be sufficient for the purposes of this Order that said warning sign or signs be erected on only one side of the road.
