

**THE HIGHLAND COUNCIL (MILTON OF LEYS PRIMARY) (PART TIME 20MPH SPEED LIMIT) AND (BALVONIE BRAES, MILTON OF LEYS) (20MPH SPEED LIMIT) ORDER 2022**

The Highland Council in exercise of the powers conferred on them by Section 84 of the Road Traffic Regulation Act 1984 and of all other powers enabling them in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act hereby make the following order: -

**General**

- 1) The Order may be cited as "The Highland Council (Milton of Leys) (Part Time 20mph Speed Limit) and (Balvonie Braes, Milton of Leys) (20mph Speed Limit) Order 2022" shall come into effect on 24<sup>th</sup> April 2023.
- 2) The Interpretation Act 1978 shall apply for the Interpretation of the Order as it applies for the Interpretation of an Act of Parliament.
- 3) All provisions contained in any Order enactment or others insofar as the same are inconsistent with the provisions of this Order and the true intent and meaning hereof shall cease to have effect and are hereby revoked.

**Part Time 20mph Speed Limit – Milton Of Leys Primary**

- 4) No person shall drive or cause or permit any vehicle to be driven in excess of 20mph on the length of road specified in Part 1 of the Schedule and signed as relative to this order at a speed in excess of 20 miles per hour at a time when the amber lights on any traffic sign or signs warning of this restriction are flashing.
- 5) It shall be sufficient for the purposes of this Order that said warning sign or signs be erected on only one side of the road.

**20mph Speed Limit – Balvonie Braes, Milton Of Leys**

- 6) No person shall drive or cause or permit any vehicle to be driven in excess of 20mph on the lengths of road specified in Part 2 of the said Schedule.

**SCHEDULE**

**Part 1 – Part time 20 Mph Speed Limit**

**Route U5180 - Milton Of Leys Road**

Commencing at a point 43 metres southeast of its junction with Macaskill Drive (Route U5060) then continuing generally westwards to a point 110 metres east of its junction with Redwood Avenue (Route U5060), a total distance of 330metres or thereby.

**Part 2 – 20 Mph Speed Limit**

**Route U5462 - Balvonie Street**

Commencing at a point 12 metres northwest of its junction with Milton Leys Road (Route U5180) then continuing generally north westwards for its remaining length.

**Route U5466 - Balvonie Terrace**

For its entire length

**Route U5463 - Balvonie Brae**

For its entire length

**Route U5465 - Balvonie Square**

For its entire length

**Route U5464 – Balvonie Green**

For its entire length
