# THE HIGHLAND COUNCIL (VARIOUS SCHOOLS IN LOCHABER NO. 1) (PART TIME 20MPH SPEED LIMIT) ORDER 2004

The Highland Council in exercise of the powers conferred on them by Section 84 of the Road Traffic Regulation Act 1984 and of all powers enabling them in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act hereby make the following order :-

## GENERAL

1. This Order may be cited as "The Highland Council (Various Schools in Lochaber No. 1) (Part Time 20mph Speed Limit) Order 2004" and shall come into effect on 20 June 2005.

2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

3. All provisions contained in any Order enactment or others insofar as the same are inconsistent with the provisions of this Order and the true intent and meaning hereof shall cease to have effect and are hereby revoked.

## ROADS (20 MPH)

4. No person shall drive or cause to be driven any vehicle on the lengths of road specified in the Schedule annexed and signed as relative to this Order at a speed in excess of 20 miles per hour at a time when the amber lights on any traffic sign or signs warning of this restriction are flashing.

5. It shall be sufficient for the purposes of this Order that said warning sign or signs be erected on only one side of the road.

# SCHEDULE TO THE HIGHLAND COUNCIL (VARIOUS SCHOOLS IN LOCHABER NO. 1) (PART TIME 20MPH SPEED LIMIT) ORDER 2004

## C84 Clovullin Road, Ardgour

From a point 10 metres or thereby east of the extended west kerb line on Buchanan Place, west and then south westwards for a distance of 121 metres or thereby.

## C48 Earl of Inverness Road, Inverlochy

From a point 13 meters or thereby south of the extended south kerb-line on Nevis Road, southwards and eastwards to a point 97 metes or thereby west of the junction with the A82(T) Fort William to Inverness trunk road, a distance of 184 metres or thereby.

#### B8008 Morar Loop Road

From a point 62 metres or thereby north of the extended boundary between the dwellings known as 1 and 2 Bayview Cottages, Morar, southwards for a distance of 212 metres or thereby.

## C86 Victoria Road/Fassifern Road/U283 Dudley Road, Fort William

- (a) From a point 5 metres or thereby north east of the north east boundary of St Andrew's East, Victoria Road, north eastwards for a distance of 161 meters or thereby
- (b) From a point 8 metres or thereby south west of the boundary between the Belford Hospital and St Mary's Roman Catholic Primary School, Fassifern Road, southwestwards on Fassifern Road and Dudley Road for a distance of 122 metres or thereby.

## A 884 Cranoch to Lochaline Pier Road


From a point 58 metres or thereby north of the centre line on the U77 Lochaline to Drimnin road southwards for a distance of 194 metres or thereby.


#### Statement of Reasons




