Invergordon Town Hall regeneration project - Letter of Support

I am writing in support of Invergordon Museum's proposal to revitalise the Town Hall on Invergordon High Street. The project seeks to further the regeneration of Invergordon town centre by returning a community-led focus to the High Street. If successful, it will bring a community asset back into public use and enable positive associative regeneration. The project will address current policy goals around 20-minute Neighbourhoods outlined in NPF4 and aid in community wealth-building, should the project meet its stated goals.

Architecture & Design Scotland are delivering the Climate Action Towns project in Invergordon, one of nine small towns with historically limited action on climate change. The project is supported by the Scottish Government. Architecture & Design Scotland through the Eight Carbon Conscious Place Principles advocate for a place-based response to improving our towns. This is a long-term commitment which requires stamina, passion and wide-ranging participation from all partners. The project proposed at Invergordon Town Hall will help achieve the goals of the eight Place Principles with particular emphasis on 1) A place led approach; 2) A place designed for and with local people; and 8) A place designed in time.

We are keen that this project delivers on its proposed outcomes and will be working closely with the Invergordon Umbrella Group, comprising the anchor organisations in the town including the Invergordon Museum, over the next year to help shape the community engagement programme and ensure continued public involvement in this project and others.

For all the reasons I have highlighted in this letter, I believe that the Town Hall regeneration project, as proposed by the Invergordon Museum, can be pivotal in revitalising the fortunes of Invergordon by providing a focal point for the community to understand that positive change can happen on the ground. It will also provide Invergordon with some much needed community services.
