As a Local Authority, we often get asked for information on compensation claims in slightly different ways. Depending on the information requested, sometimes we can answer these queries and sometimes we can't. This isn't an attempt by us to prevent data from being made public, but we can only provide the information which is available.

Most enquiries relate to finding out how many requests for compensation were received for vehicle or pothole related damage, the number or total amount paid or refuted each year. The following questions and answers attempt to provide the information we have in the various formats requested.

Data in the following tables was provided in August and September 2023. Note that the data supplied will vary as claims are processed.

## 7. Where can I find a compensation claim form? Compensation claim forms can be obtained by phoning 01349 886601.

# 8. How does The Highland Council process a compensation claim? Initial claim enquiries are processed by one of our staff who will arrange for a compensation claim form to be sent to you by post or email. Once the Council has received a completed claim form, along with all the supporting evidence required, the claim is acknowledged and investigated. Once the evidence has been reviewed by an Area Road Operations Manager, a decision is made and the claimant is informed of the outcome by letter. If the resulting decision is to settle, a member of staff will arrange payment by issuing a BACS form to the claimant.

## 9. My car was damaged when I hit a pothole, why has my claim been rejected?

It is not practical or affordable for The Highland Council to maintain all its roads and infrastructure in a defect free condition all the time nor, does the law require us to do so. Making a claim does not automatically entitle a claimant to compensation for loss or injury, it will depend on whether the Council has breached its 'duty of care'.

#### 10. Who provides The Highland Council with their insurance?

The Highland Council is self-insured, paying compensation from its own funds for claim amounts up to £1,000,000. Any compensation amounts over £1,000,000 are handled by The Highland Council's insurance provider Zurich Municipal.

### 11. What happens if The Highland Council discovers a claim to be fraudulent?

In order to protect public funds, claims discovered to be fraudulently intimated, falsely stated or exaggerated will be passed to the relevant authority and may be subject to criminal prosecution.
