Introduction

This Supporting Statement forms part of the Local Place Plan submission to The Highland Council and is accompanying the **Dores and Essich Local Place Plan** dated 16/08/2024 by Dores and Essich Community Council.

The Local Place Plan covers the Dores and Essich Community Council area.

The Local Place Plan and this statement have been prepared in accordance with:

- Scottish Government Planning Circular 1/2022 Local Place Plans

The Plan covers the **Dores and Essich Community Council** area which lies southwest of Inverness, starting at Torbreck and running along the shore of Loch Ness. Dores is the main settlement in the area, located approximately in the mid-point, and 10km from Inverness. It stretches northeast of the loch to encompass the settlements of Scaniport and Essich.

A map of the Community Council area can be seen in the Plan.

The plan should be read in conjunction with our <u>Community Action Plan</u> published in June 2024, which contains our aspirations and action priorities for the next 10 years.

The purpose of the Local Place Plan is to help the community, public bodies, landowners, businesses and funders understand how those aspirations and actions for the development and use of landand and make change happen to achieve better outcomes for people and communities.

Reasons for amendments being sought to the Local Development Plan

The Local Place Plan contains a number of suggestions for the Council to consider as it prepares the forthcoming Highland Local Development Plan and sets out reasons why these should be considered. These are contained in the table on pages 26-28 of the Local Place Plan, together with reasons, as required by Scottish Government Circular 1-2022 'Local Place Plans', paragraphs 32-33xi.

Community support for the Local Place Plan

The community engagement process used to develop the Local Place Plan, along with the levels of participation, is explained in section 4 of the Plan. It combined the engagement undertaken for the Community Action Plan in 2024 with additional community engagement for the Local Place Plan in June. This consisted of two in-person events in Dores Parish Hall in the afternoon/evening at which people were invited to record their views on annotated maps of the area. Following on from this, there was an open consultation period on the draft LPP with an online feedback form which ran for 28 days in July/August 2024. As well as being open to the general public, neighbouring Community Councils and the Councillors for the Ward were specifically invited to comment on the draft LPP – the notices inviting comments are included in the appendices to this submission statement.

The Community Council is satisfied that the Local Place Plan provides an accurate and evidence-based view of local residents' views on the development or use of land and buildings in its area.
